



DIGEST OF SB 185 (Updated February 9, 2021 10:54 am - DI 107)

Citations Affected: Noncode.

**Synopsis:** Home based vendors. Requires that the state department of health, state board of animal health, and state department of agriculture shall, in consultation with industry groups and food safety experts, submit recommendations concerning home based vendors to the general assembly.

Effective: July 1, 2021.
