SENATE BILL No. 187

DIGEST OF SB 187 (Updated February 2, 2021 1:57 pm - DI 106)

Citations Affected: IC 10-10.7.

Synopsis: Protection of monuments, memorials, and statues. States the policy of the state of Indiana regarding the protection of monuments, memorials, and statues. Requires the state police department to prioritize the investigation and prosecution of persons who destroy, damage, vandalize, or desecrate a monument, memorial, or statue. Requires the state police department to assist political subdivisions in the investigation and prosecution of persons who destroy, damage, vandalize, or desecrate a monument, memorial, or statue. Provides that it is state policy to withhold state support relating to public spaces for political subdivisions that fail to protect public monuments, memorials, and statues and from political subdivisions that have failed to protect public monuments, memorials, and statues from destruction or vandalism.

Effective: July 1, 2021.

SENATE BILL No. 187

A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 10-10.7 IS ADDED TO THE INDIANA CODE AS
2 A **NEW** ARTICLE TO READ AS FOLLOWS [EFFECTIVE JULY 1,
3 2021]:

4 **ARTICLE 10.7. PROTECTION OF MONUMENTS,**
5 **MEMORIALS, AND STATUES**

6 **Chapter 1. Statement of Policy**

7 **Sec. 1. It is the policy of the state of Indiana to prosecute to the**
8 **fullest extent permitted under Indiana and federal law, and as**
9 **appropriate, any person that destroys, damages, vandalizes, or**
10 **desecrates a private or government monument, memorial, statue,**
11 **or other commemorative property.**

12 **Sec. 2. It is the policy of the state of Indiana to prosecute to the**
13 **fullest extent permitted under Indiana and federal law, and as**
14 **appropriate, any person that participates in efforts to incite**
15 **violence, rioting, or other illegal activity in connection with acts**
16 **described in section 1 of this chapter.**

17 **Sec. 3. It is the policy of the state of Indiana to prosecute to the**

1 fullest extent permitted under Indiana and federal law, and as
2 appropriate, any person that damages, defaces, or destroys
3 religious property.

4 Sec. 4. It is the policy of the state of Indiana, as appropriate and
5 consistent with applicable Indiana and federal law, to withhold
6 state support for public spaces of political subdivisions that fail to
7 protect public monuments, memorials, and statues.

8 Sec. 5. It is the policy of the state of Indiana, as appropriate and
9 consistent with applicable Indiana and federal law, to withhold
10 state support from political subdivisions that have failed to protect
11 public monuments, memorials, and statues from destruction or
12 vandalism.

13 Chapter 2. Definitions

14 Sec. 1. The definitions in this chapter apply throughout this
15 article.

16 Sec. 2. "Department" refers to the state police department
17 established by IC 10-11-2-4.

18 Sec. 3. "Person" refers to an individual, a sole proprietorship,
19 an association, a business association, a fiduciary, a partnership, a
20 corporation, a limited liability company, a joint stock company, a
21 joint venture, or other legal entity.

22 Sec. 4. "Political subdivision" has the meaning set forth in
23 IC 36-1-2-13.

24 Sec. 5. "State agency" has the meaning set forth in IC 4-13-1-1.

25 Sec. 6. "State support" refers to appropriations made by the
26 general assembly.

27 Chapter 3. Enforcement

28 Sec. 1. (a) The department shall prioritize within the
29 department the investigation and prosecution of activities
30 described in IC 10-10.7-1.

31 (b) The department shall take all appropriate enforcement
32 actions against persons found to have violated Indiana law through
33 the investigations described in subsection (a).

34 Sec. 2. The department shall, as appropriate and consistent with
35 applicable Indiana and federal law, work with political
36 subdivisions to ensure that the state government appropriately
37 provides information and assistance to those political subdivisions
38 in connection with their investigations or prosecution of activities
39 described in IC 10-10.7-1, regardless of whether the property is
40 located on property owned by the state.

41 Sec. 3. Upon request, the department shall provide, as
42 appropriate and consistent with Indiana and federal law, personnel



1 to assist with the protection of monuments, memorials, statues, or
2 property owned by the state or a political subdivision.

3 **Chapter 4. State Support**

4 **Sec. 1. Each state agency shall examine their respective grant**
5 **programs and apply the policies established by IC 10-10.7-1 to all**
6 **such programs to the extent that the application of those policies**
7 **is both appropriate and consistent with applicable Indiana and**
8 **federal law.**
