

SENATE BILL No. 196

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-31-8-5.4.

Synopsis: Expiration of emergency rules. Provides that an emergency rule concerning categories or designations of school improvement adopted by the state board of education expires on the earlier of December 19, 2014, or the effective date of a rule that supersedes the emergency rule. (Current law provides that an emergency rule expires on the earlier of November 15, 2014, or the effective date of a rule that supersedes the emergency rule.)

Effective: July 1, 2014.

SENATE BILL No. 196

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-31-8-5.4, AS ADDED BY SEA 24-2014,
2 SECTION 88, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2014]: Sec. 5.4. (a) Not later than November 15, 2013, the
4 state board shall establish new categories or designations of school
5 performance under the requirements of this chapter to replace 511
6 IAC 6.2-6. The new standards of assessing school performance:
7 (1) must be based on a measurement of individual student
8 academic performance and growth to proficiency; and
9 (2) may not be based on a measurement of student performance
10 or growth compared with peers.
11 511 IAC 6.2-6 is void on the effective date of the emergency or final
12 rules adopted under this section.
13 (b) After July 1, 2013, the state board:
14 (1) shall adopt rules under IC 4-22-2; and
15 (2) may adopt emergency rules in the manner provided in
16 IC 4-22-2-37.1;
