

## **ENGROSSED** SENATE BILL No. 209

DIGEST OF SB 209 (Updated February 11, 2014 9:11 am - DI 84)

Citations Affected: IC 5-10.3.

**Synopsis:** Public employee contributions to ASA only pension plan. Permits a member of the public employees' defined contribution plan (ASA only plan) to make contributions to the ASA only plan in addition to the required contribution of 3% of the member's compensation paid by the state on behalf of the member each year. Provides that additional contributions to the ASA only plan are made on the same basis and subject to the same limitations as additional contributions made by a member of the public employees' retirement fund.

Effective: July 1, 2014.

### ENGROSSED SENATE BILL No. 209

A BILL FOR AN ACT to amend the Indiana Code concerning pensions.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 5-10.3-12-23, AS ADDED BY P.L.22-2011,
SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
JULY 1, 2014]: Sec. 23. (a) Each member's contribution to the plan is
equal to three percent (3%) of the member's compensation. The state
shall pay the member's contribution on behalf of each member of the
plan each year.

- (b) To the extent permitted by the Internal Revenue Code and applicable regulations, a member of the plan may make contributions to the plan in addition to the contribution required under subsection (a). IC 5-10.2-3-2(c) and IC 5-10.2-3-2(d) govern additional contributions made under this subsection.
- (b) (c) Member contributions will be credited to the member's account as specified in IC 5-10.2-3.
- (c) (d) Although designated as employee contributions, the contributions made under subsection (a) are picked up and paid by the state as the employer in lieu of the contributions being paid by the

- employee in accordance with section 414(h)(2) of the Internal Revenue Code. A member may not receive any amounts paid by the state under this section directly instead of having the amounts paid to the plan.
