

SENATE BILL No. 219

DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-36-6.

Synopsis: Physician order for scope of treatment. Requires an individual's treating physician to evaluate an individual's mental capacity before a physician order for scope of treatment (POST) form may be executed. Specifies that the first POST form executed by an individual is effective for six months but may be renewed with no expiration.

Effective: July 1, 2014.

SENATE BILL No. 219



A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 16-36-6-8, AS ADDED BY P.L.164-2013,
- 2 SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 3 JULY 1, 2014]: Sec. 8. (a) A POST form may be executed only by an
- 4 individual's treating physician and only if:
- 5 (1) the treating physician has determined that:
- 6 (A) the individual is a qualified person; ~~and~~
- 7 **(B) the individual is mentally able to understand executing**
- 8 **a POST form; and**
- 9 ~~(B)~~ **(C) the medical orders contained in the individual's POST**
- 10 **form are reasonable and medically appropriate for the**
- 11 **individual; and**
- 12 (2) the qualified person or representative has completed the POST
- 13 form in accordance with section 7 of this chapter.
- 14 (b) The:
- 15 (1) treating physician; and
- 16 (2) qualified person or representative;



1 must sign and date the POST form for the POST form to be effective.
2 SECTION 2. IC 16-36-6-10.5 IS ADDED TO THE INDIANA
3 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
4 [EFFECTIVE JULY 1, 2014]: **Sec. 10.5. (a) A POST form executed**
5 **the first time by a qualified declarant or a qualified declarant's**
6 **health care representative for a condition or illness described in**
7 **section 5 of this chapter is effective for six (6) months from the date**
8 **of the execution.**
9 (b) A POST form may be renewed and, upon renewal, does not
10 expire unless revoked.
