# **SENATE BILL No. 232**

DIGEST OF INTRODUCED BILL

Citations Affected: IC 5-20-10.

**Synopsis:** Access to food program. Establishes the access to food program (program) under the administration of the Indiana housing and community development authority (IHCDA). Provides that the purpose of the program is to focus on: (1) distribution of fresh and nutritious food; and (2) education in food preparation and nutrition in food deserts. Defines "food desert". Requires the IHCDA to convene an annual meeting to share best practices and information concerning effective programs.

Effective: July 1, 2018.

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

14	have incomes that are below the federal income poverty
