## **SENATE BILL No. 233**

DIGEST OF SB 233 (Updated February 4, 2015 2:34 pm - DI 116)

Citations Affected: IC 20-30; IC 36-1.

**Synopsis:** Winter holidays in schools, cities, and towns. Provides that a school corporation may: (1) instruct students about the history of traditional winter celebrations; (2) allow the use of traditional greetings concerning the celebrations; and (3) display on school property scenes or symbols associated with traditional winter celebrations if certain conditions are met and the scenes or symbols do not include a message that encourages a particular religious belief. Requires the state board of education to develop guidelines to assist school corporations in developing appropriate instruction and displays. Provides that the legislative body of a city, including a consolidated city, or town may adopt an ordinance that: (1) allows employees to use traditional greetings concerning traditional winter celebrations; and (2) allows the display on city or town property scenes or symbols associated with traditional winter celebrations if certain conditions are met and the scenes or symbols associated with traditional winter celebrations; and (2) allows the display on city or town property scenes or symbols associated with traditional winter celebrations if certain conditions are met and the scenes or symbols do not include a message that encourages a particular religious belief.

Effective: July 1, 2015.

# SENATE BILL No. 233

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 20-30-6-18 IS ADDED TO THE INDIANA CODE
2	AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3	1, 2015]: Sec. 18. (a) Each school corporation may:
4	(1) instruct students about the history of traditional winter

6	(2) allow students and employees to offer traditional greetings
7	regarding the celebrations, including:
8	(A) "Merry Christmas";
9	(B) "Happy Hanukkah";
10	(C) "Happy Holidays"; and
11	(D) other seasonal greetings.
12	(b) Except as provided in subsection (c), a school corporation
13	may display on property owned by the school corporation scenes
14	or symbols associated with traditional winter celebrations,
15	including a menorah, Christmas tree, Nativity scene, or other
16	religious symbol associated with traditional winter celebrations, if

12	1, 2015]: Sec. 18. (a) This section applies only to cities, including a
13	consolidated city, and towns.
14	(b) The legislative body of a city or town may adopt an
15	ordinance that allows employees to offer traditional greetings
16	regarding the celebrations, including:
17	(1) "Merry Christmas";
18	(2) "Happy Hanukkah";
19	(3) "Happy Holidays"; and
20	(4) other seasonal greetings.
21	(c) Except as provided in subsection (d), a city or town may
