# **SENATE BILL No. 233**

DIGEST OF INTRODUCED BILL

Citations Affected: IC 25-26.

**Synopsis:** Pharmacy technicians. Changes pharmacy technician certification to licensure. Adds a high school graduation, high school equivalency certificate, or state general educational development requirement for pharmacy technician licensure. Specifies education and training requirements. Requires passage of a specified certification examination beginning July 1, 2015. Specifies that individuals with certificates who are in good standing will be considered to have licensure.

Effective: July 1, 2014.

### Introduced

#### Second Regular Session 118th General Assembly (2014)

# **SENATE BILL No. 233**

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 25-26-13-18, AS AMENDED BY P.L.159-2012,
2	SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	JULY 1, 2014]: Sec. 18. (a) To be eligible for issuance of a pharmacy
4	permit, an applicant must show to the satisfaction of the board that:
5	(1) Persons at the location will engage in the bona fide practice of
6	pharmacy. The application must show the number of hours each
7	week, if any, that the pharmacy will be open to the general public.
8	(2) The pharmacy will maintain a sufficient stock of emergency
9	and frequently prescribed drugs and devices as to adequately
10	serve and protect the public health.
11	(3) Except as provided in section 19 of this chapter, a registered
12	pharmacist will be in personal attendance and on duty in the
13	licensed premises at all times when the practice of pharmacy is
14	being conducted and that the pharmacist will be responsible for
15	the lawful conduct of the pharmacy.
16	(4) Certified Licensed pharmacy technicians or pharmacy

1 2	technicians in training <b>who are licensed</b> or certified under
$\frac{2}{3}$	IC 25-26-19 must practice under a licensed pharmacist's immediate and personal supervision at all times. A pharmacist
4	may not supervise more than six (6) pharmacy technicians or

24	(F) have such additional fixtures, facilities, and equipment as
25	the board requires to enable it to operate properly as a
26	pharmacy in compliance with federal and state laws and
27	regulations governing pharmacies.
28	(b) Prior to opening a pharmacy after receipt of a pharmacy permit,
29	the permit holder shall submit the premises to a qualifying inspection
30	by a representative of the board and shall present a physical inventory
31	of the drug and all other items in the inventory on the premises.
32	(c) At all times, the wholesale value of the drug inventory on the
33	licensed items must be at least ten percent (10%) of the wholesale
34	value of the items in the licensed area.

(a) A pharmacy technician 21 certificate license expires on a date set by the Indiana professional 22 licensing agency in each even-numbered year. 23 (b) An application for renewal of a pharmacy technician certificate 24 license must be accompanied by the appropriate fee. 25 (c) If a person fails to renew a pharmacy technician <del>certificate,</del> 26 license, the certificate license may be reinstated by meeting the 27 requirements under IC 25-1-8-6. 28 (d) The board may require a person who applies for a certificate 29 license under subsection (c) to appear before the board and explain the reason why the person failed to renew a pharmacy technician 30 31 certificate. license. 32 SECTION 7. IC 25-26-19-8 IS AMENDED TO READ AS 33 FOLLOWS [EFFECTIVE JULY 1, 2014]: Sec. 8. A certified licensed 34 pharmacy technician may not perform the following activities: (1) Providing advice or consultation with the prescribing 35 36 practitioner or other licensed health care provider regarding the 37 patient or the interpretation and application of information contained in the prescription or drug order, medical record, or 38 39 patient profile. 40 (2) Providing advice or consultation with the patient regarding the 41 interpretation of the prescription or the application of information 42 contained in the patient profile or medical record.

1	(3) Dispensing prescription drug information to the patient.
2	(4) Final check on all aspects of the completed prescription and
3	assumption of the responsibility for the filled prescription,
4	including the appropriateness of the drug for the patient and the
5	accuracy of the:
6	(A) drug dispensed;
7	(B) strength of the drug dispensed; and
8	(C) labeling of the prescription.
9	(5) Receiving a new prescription drug order over the telephone or
10	electronically unless the original information is recorded so a
11	pharmacist may review the prescription drug order as transmitted.
12	(6) Any activity required by law to be performed only by a
13	pharmacist.
14	(7) Any activity that requires the clinical judgment of a
15	pharmacist and is prohibited by a rule adopted by the board.
16	SECTION 8. IC 25-26-19-9, AS AMENDED BY P.L.158-2013,
17	SECTION 290, IS AMENDED TO READ AS FOLLOWS
18	[EFFECTIVE JULY 1, 2014]: Sec. 9. (a) An individual may not
19	practice as a pharmacy technician unless the individual is certified
20	licensed under this chapter.
21	(b) An individual may not act as a pharmacy technician in training
22	unless the individual has obtained a permit under this chapter or the
23	individual is acting as a pharmacy technician in training during the
24	period permitted under section 6(b) of this chapter.
25	(c) An individual who knowingly violates this section commits a
26	Level 6 felony.
