DIGEST OF SB 234 (Updated January 30, 2014 2:37 pm - DI 109)

Citations Affected: IC 25-6.1; noncode.

Synopsis: Auctioneer licensing. Repeals the auction house license provisions. Provides that a person holding an unexpired auction house license may apply to convert that license to an auction company license. Repeals the temporary auctioneer's permit provisions. Provides that the auctioneer commission may use interest earned from the funds in the auctioneer recovery fund for expenses related to the continuing education program and other expenses incurred by the commission. Allows the auctioneer commission to hire an education officer to oversee and perform the educational duties required under the auctioneer licensing laws. Makes conforming changes. Makes a technical correction.

Effective: Upon passage; July 1, 2014.

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 25-6.1-1-3, AS AMENDED BY P.L.1-2006,
2 SECTION 422, IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2014]: Sec. 3. As used in this article:

4 "Auction" means a sale transaction conducted by means of oral or
5 written exchanges between an auctioneer and the members of the
6 auctioneer's audience, which exchanges consist of a series of
7 invitations for offers for the purchase of goods or real estate made by
8 the auctioneer and offers to purchase made by members of the audience
9 and culminate in the acceptance by the auctioneer of the highest or
10 most favorable offer made by a member of the participating audience.

11 "Auction company" means any person or persons who, as a part of
12 its business, arranges, manages, sponsors, advertises, or carries out
13 auctions.

14 "Auction house" means an established place of business including
15 an auction barn, a sale barn, and a sale pavilion and its contiguous
16 surroundings where two (2) or more auctions are held within any

1 twelve (12) month period and where representations are regularly made
 2 that goods are sold at auction. Each day during which goods or real
 3 estate are being offered for sale at auction shall constitute one (1)
 4 auction. A sale barn or livestock auction market that is used exclusively
 5 for the auctioning of livestock and is licensed by the Indiana state
 6 board of animal health is not an auction house as defined herein.

7 "Auctioneer" means an individual who is engaged in, or who by
 8 advertising or otherwise holds the individual out as being available to
 9 engage in, the calling for, the recognition of, and the acceptance of
 10 offers for the purchase of goods or real estate at an auction.

11 "Commission" means the Indiana auctioneer commission.

12 "Goods" means any goods, wares, chattels, merchandise, or other
 13 personal property, including domestic animals and farm products.

14 "Licensee" means any person licensed or issued a temporary permit
 15 under this article and, in the case of an auction house or auction
 16 company, includes the person required to obtain a license for such
 17 auction house or auction company.

18 "Organization" means a corporation, a limited liability company, a
 19 partnership, a trust (specifically including a business trust), a firm, an
 20 association, or any other form of business enterprise which is owned by
 21 two (2) or more individuals.

22 "Person" means an organization or an individual.

23 "Real estate" means any right, title, or interest in real property,
 24 including fixtures.

25 "Licensing agency" means the Indiana professional licensing agency
 26 established by IC 25-1-5-3.

27 SECTION 2. IC 25-6.1-2-5 IS AMENDED TO READ AS
 28 FOLLOWS [EFFECTIVE JULY 1, 2014]: Sec. 5. (a) The commission
 29 is empowered to do the following:

- 30 (1) Administer and enforce the provisions of this article.
- 31 (2) Adopt such rules in accordance with IC 4-22-2 and such forms
 32 as are necessary or appropriate for the administration and the
 33 effective and efficient enforcement of this article.
- 34 (3) Issue, suspend, and revoke licenses in accordance with this
 35 article.
- 36 (4) Subject to IC 25-1-7, investigate complaints concerning
 37 licensees or persons the commission has reason to believe should
 38 be licensees, specifically including complaints respecting failure
 39 to comply with this article or the rules, and to take appropriate
 40 action pursuant to IC 25-1-11.
- 41 (5) Bring actions, in the name of the state of Indiana, in an
 42 appropriate circuit court in order to enforce compliance with this

2 (6) Hold public hearings on any matters for which a hearing is

5 (7) Adopt a seal and, through its secretary, certify copies.

6 (b) The licensing agency shall provide necessary employees and
7 consultants to enforce this article.

8 (c) The commission shall adopt rules under IC 4-22-2 establishing

11 (A) practice as an auctioneer; and

12 (B) operation of an auction company. ~~or auction house.~~

13 (2) Continuing education requirements for an individual who has
14 reactivated an auctioneer license with less than twelve (12)
15 months remaining in the licensing period.

16 SECTION 3. IC 25-6.1-3-1 IS AMENDED TO READ AS
17 FOLLOWS [EFFECTIVE JULY 1, 2014]: Sec. 1. Coverage. (a) Except
18 as provided in subsection (b), ~~of this section,~~ no individual may act as
19 an auctioneer and no person may operate ~~an auction house~~ or an
20 auction company without obtaining and having in full force and effect
21 a valid license issued by the commission in accordance with this
22 chapter.

23 (b) The requirements of this article do not apply to:

24 (1) An auction of goods or real estate conducted exclusively by
25 individuals who personally own such goods or real estate and who
26 did not acquire such goods or real estate for resale.

27 (2) An auction conducted by or under the direction of any public
28 authority.

29 (3) An auction conducted pursuant to any judicial order or to the
30 settlement of a decedent's estate.

31 (4) A sale conducted by or on behalf of any political party,
32 church, charitable corporation, or association if the individual
33 conducting the sale receives no compensation and does not, by
34 advertising or otherwise, hold himself ~~or herself~~ out as being
35 available to engage in the sale of goods or real estate at auction.

36 SECTION 4. IC 25-6.1-3-2, AS AMENDED BY P.L.105-2008,
37 SECTION 16, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
38 JULY 1, 2014]: Sec. 2. (a) Every individual, before acting as an
39 auctioneer, must obtain a license from the commission.

40 (b) An applicant for a license must:

41 (1) be at least eighteen (18) years of age;

42 (2) have completed at least eighty (80) actual hours of auction



- 1 instruction from a course provider approved by the commission;
 2 (3) not have a conviction for:
 3 (A) an act which would constitute a ground for disciplinary
 4 sanction under IC 25-1-11; or
 5 (B) a felony that has a direct bearing on the applicant's ability
 6 to practice competently.
- 7 (c) Auction instruction required under subsection (b) must provide
 8 the applicant with knowledge of all of the following:
 9 (1) The value of real estate and of various goods commonly sold
 10 at an auction.
 11 (2) Bid calling.
 12 (3) Sale preparation, sale advertising, and sale summary.
 13 (4) Mathematics.
 14 (5) The provisions of this article and the commission's rules.
 15 (6) Any other subject matter approved by the commission.
- 16 (d) An individual seeking an initial license as an auctioneer under
 17 this article shall file with the commission a completed application on
 18 the form prescribed by the commission. When filing an application for
 19 an auctioneer license, each individual shall pay a nonrefundable
 20 examination fee established by the commission under IC 25-1-8-2.
- 21 (e) When applying for a renewal of an auctioneer license, each
 22 individual shall do the following:
 23 (1) Apply in a manner required by the commission, including
 24 certification by the applicant that the applicant has complied with
 25 the requirements of IC 25-6.1-9-8, unless the commission has
 26 granted the applicant a waiver under IC 25-6.1-9-9.
 27 (2) Pay the renewal fee established by the commission under
 28 IC 25-1-8-2.
- 29 (f) Upon the receipt of a completed application for an initial or a
 30 renewal license, the commission shall examine the application and may
 31 verify the information contained therein.
- 32 (g) An applicant who is seeking an initial license must pass an
 33 examination approved by the commission that covers subjects and
 34 topics of knowledge required to practice as an auctioneer. The
 35 commission shall hold examinations as the commission may prescribe.
- 36 (h) The commission shall issue an auctioneer's license, in such form
 37 as it may prescribe, to each individual who meets all of the
 38 requirements for licensing and pays the appropriate fees.
- 39 (i) Auctioneer licenses shall be issued for a term of four (4) years.
 40 A license expires at midnight on the date established by the licensing
 41 agency under IC 25-1-6-4 and every fourth year thereafter, unless
 42 renewed before that date. If the license has expired, it may be reinstated

7 applicant pass an examination and that the nonresident submit written
8 statements by two (2) individuals, if the nonresident applicant:

9 (1) is licensed to act as an auctioneer in the state of the applicant's
10 domicile;

11 (2) submits with the application a duly certified letter of
12 certification issued by the licensing board of the applicant's
13 domiciliary state;

14 (3) is a resident of a state whose licensing requirements are
15 substantially equal to the requirements of Indiana;

16 (4) is a resident of a state that grants the same privileges to the
17 licensees of Indiana; and

18 (5) includes with the application an irrevocable consent that
19 actions may be commenced against the applicant. The consent
20 shall stipulate that service of process or pleadings on the
21 commission shall be taken and held in all courts as valid and
22 binding as if service of process had been made upon the applicant
23 personally within this state. If any process or pleading mentioned
24 in this subsection is served upon the commission, it shall be by
25 duplicate copies. One (1) of the duplicate copies shall be filed in
26 the office of the commission and one (1) shall be immediately
27 forwarded by the commission by registered or certified mail to the
28 applicant against whom the process or pleadings are directed.

29 (l) The commission may enter into a reciprocal agreement with
30 another state concerning nonresident applicants.

31 ~~(m) The commission may, for good cause shown, upon the receipt~~
32 ~~of an application for a license, issue a temporary permit for such~~
33 ~~reasonable period of time, not to exceed one (1) year, as the~~
34 ~~commission deems appropriate. A temporary permit has the same~~

37 (j) The holder of an auction house license that has been expired for

40 (k) The holder of an auction house license that has been expired for
41 more than four (4) years may have the license reinstated by satisfying

11 in subsection (a) for the two (2) year period beginning on July 1 of the
12 current year through June 30 of the next odd-numbered year.

- 17 **emergency rules must be adopted and in effect before July 1, 2014.**
- 18 **The emergency rules expire on the earlier of:**
- 19 (1) the date permanent rules are adopted under
- 20 IC 25-6.1-3-4(c), as amended by this act; or
- 21 (2) June 30, 2015.
- 22 **This SECTION expires July 1, 2015.**
- 23 SECTION 17. **An emergency is declared for this act.**
