# **SENATE BILL No. 241**

DIGEST OF INTRODUCED BILL

Citations Affected: IC 33-35-2.

**Synopsis:** City and town court jurisdiction. Specifies that the jurisdiction of a city or town court with respect to misdemeanors and infractions extends only to misdemeanors and infractions committed within the city or town.

Effective: July 1, 2018.

A BILL FOR AN ACT to amend the Indiana Code concerning courts and court officers.

### Be it enacted by the General Assembly of the State of Indiana:

8	(3) If the city that established the city court has entered into an
9	interlocal agreement described in IC 33-35-1-6 with another city
10	or a town, jurisdiction of all other ordinance violations described
11	in the interlocal agreement.
12	SECTION 2. IC 33-35-2-8, AS AMENDED BY P.L.55-2010,
13	SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
14	JULY 1, 2018]: Sec. 8. (a) A town court has exclusive jurisdiction of
15	all violations of the ordinances of the town.
16	(b) A town court also has jurisdiction of all misdemeanors and all
17	infractions committed within the town.

(c) If the town that established the town court has entered into an
interlocal agreement described in IC 33-35-1-6 with a city or another
town, the town court has jurisdiction of all other ordinance violations
described in the interlocal agreement.
