DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-46-8-11.

Synopsis: Kidney early evaluation fund. Establishes the kidney early evaluation fund, and annually appropriates \$50,000 to the fund. Distributes money quarterly from the fund to the National Kidney Foundation of Indiana (foundation) to administer the Kidney Early Evaluation Program (KEEP). Requires the foundation to submit an annual report of expenditures from the money distributed from the fund.

However, after December 31, 2015, money in the fund may not be distributed under this subsection until the annual report for the previous year required under subsection (d) has been submitted.
