SENATE BILL No. 254

DIGEST OF INTRODUCED BILL

Citations Affected: IC 2-2.1-1.

Synopsis: Limits on terms of legislative leadership. Provides that a member of the general assembly may not serve for more than six years in any particular office during the member's tenure in the general assembly. Defines office to refer to the president pro tempore of the senate; the speaker of the house of representatives; a particular office of the senate as provided under the rules of the senate; a particular office of the house of representatives as provided under the rules of the house of representatives; or the chair of a particular standing committee of the senate or the house of representatives. Provides that the limitation applies regardless of whether the member is elected or appointed to the office for a number of consecutive or nonconsecutive years. Provides that the limitation may not be construed to prevent a member of the general assembly from serving six years or fewer in separate offices during the member's tenure in the general assembly. Provides that a year served in a particular office during a term of the general assembly that ends before November 9, 2016, does not count against the limitation.

SENATE BILL No. 254

A BILL FOR AN ACT to amend the Indiana Code concerning the general assembly.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 2-2.1-1-6 IS AMENDED TO READ AS
FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 6. Procedures:
Organization of the Senate. (a) The President of the Senate shall
preside at the organizational meeting during the election of the
President Pro Tempore and other officers of the Senate.

- (b) The oath of office shall be administered to senators-elect by the Chief Justice of the Supreme Court of Indiana, or an associate justice designated by the Chief Justice.
- (c) **Subject to section 14 of this chapter,** the President Pro Tempore and such other officers as may be determined by the standing rules and orders of the Senate shall be elected. The oath of office shall be administered to the President Pro Tempore by the Chief Justice, and to the other officers by the President of the Senate.
- (d) In the event there is no President or he the President is absent or unable to serve, the Chief Justice of the Supreme Court or an associate justice designated by the Chief Justice shall preside during

the election of the President Pro Tempore and, upon being elected and
sworn, the President Pro Tempore shall take the chair and conduct the
further business of the Senate until the vacancy in the office of
President is filled, if there is no President, or until the President is able
to serve, if he the President is absent or unable to serve.

- SECTION 2. IC 2-2.1-1-7 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 7. (a) The Secretary of State shall preside at the organizational meeting during the election of the Speaker of the House of Representatives.
- (b) The oath of office shall be administered to representatives-elect by the Chief Justice of the Supreme Court of Indiana, or an associate justice designated by the Chief Justice.
- (c) Subject to section sections 7.5 and 14 of this chapter, the Speaker shall be elected. The oath of office shall be administered to the Speaker of the House by the Chief Justice of the Supreme Court or an associate justice designated by the Chief Justice.
- (d) Upon being elected and taking the oath of office, the Speaker shall take the chair and conduct the further business of the House, including the election and swearing in of such other officers as may be determined by the standing rules and orders of the House of Representatives. However, the election of officers under this subsection is subject to section 14 of this chapter.
- (e) In the event there is no Secretary of State or he the Secretary of State is absent or unable to serve, the Chief Justice of the Supreme Court or an associate justice designated by the Chief Justice shall preside during the election of the Speaker.
- SECTION 3. IC 2-2.1-1-7.5 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 7.5. (a) This section applies only if the number of members of the house of representatives affiliated with one (1) political party equals the number of members of the house of representatives affiliated with a different political party.
- (b) For purposes of this section, an individual is considered to be affiliated with a political party if the individual was:
 - (1) the nominee (as defined in IC 3-5-2-33) of that political party for election to the office to which the individual was elected at the previous general election; or
 - (2) selected by that political party to fill a candidate vacancy or a vacancy in the office under IC 3-13 for the office the individual currently holds.
- (c) Subject to section 14 of this chapter, the speaker of the house of representatives and the principal clerk of the house of representatives shall be elected by the members of the house of



representatives affiliated with the political party whose:

4	(2) candidate was elected secretary of state at the previous general

7	(d) The rules that governed the house of representatives before the
8	previous general election shall govern the house of representatives after
9	the general election until those rules are amended as provided in those
10	rules.
11	SECTION 4. IC 2-2.1-1-8 IS AMENDED TO READ AS
12	FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 8. Procedures for Each
13	House at the Organizational Meeting. (a) Upon the election of the
14	officers in each house, the membership of each house shall adopt
15	standing rules and orders for their respective houses, and joint rules for
16	conducting the business in the two houses.
17	(b) Each house, by rule, shall determine such other business as the
18	respective houses may perform at the organizational meeting.
19	(c) The rules, as adopted, shall govern the respective houses for that
20	term of the General Assembly, unless amended or suspended.
21	(d) Subject to section 14 of this chapter, the officers elected at the
22	organizational meeting shall serve for that entire term of the General
23	Assembly, unless removed, suspended or unable to serve.
24	SECTION 5. IC 2-2.1-1-9 IS AMENDED TO READ AS
25	FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 9. Procedures: Standing
26	Committee Appointments. (a) By not later than ten (10) days after the
27	election of officers as provided in sections 6 and 7 of this chapter the
28	appointments to the standing committees of the two houses of the
29	General Assembly shall be made and announced by the Speaker and
30	the President Pro Tempore, respectively.
31	(b) At the reconvening in January of the first session of the term, the
32	lists of appointments to the standing committees shall be read in their
33	respective houses and recorded in the journals thereof.
34	(c) Subject to section 14 of this chapter, the members of the
35	standing committees shall serve for the term of the General Assembly
36	in which they are appointed, unless removed, suspended or unable to
37	serve.
38	SECTION 6. IC 2-2.1-1-14 IS ADDED TO THE INDIANA CODE
39	AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
40	1, 2015]: Sec. 14. (a) This section applies to a term of the general
41	assembly beginning after November 8, 2016.
42	(b) As used in this section "affice" refers to one (1) of the



following leadership positions to which a member of the general
assembly may be elected or appointed for a term of the general
assembly:

- (1) The president pro tempore of the senate.
- (2) The speaker of the house of representatives.
- (3) A particular office of the senate as provided under the rules of the senate.
- (4) A particular office of the house of representatives as provided under the rules of the house of representatives.
- (5) The chair of a particular standing committee of the senate or the house of representatives.
- (c) Subject to subsection (e), a member of the general assembly may not serve for more than six (6) years in any particular office during the member's tenure in the general assembly. The limitation imposed by this subsection applies regardless of whether the member is elected or appointed to the office for a number of consecutive or nonconsecutive years.
- (d) Subsection (c) may not be construed to prevent a member of the general assembly from serving six (6) years or fewer in separate offices during the member's tenure in the general assembly.
- (e) A year served in a particular office during a term of the general assembly that ends before November 9, 2016, does not count against the limit imposed on the number of years that the member may serve in the office by subsection (c).
