ENGROSSED SENATE BILL No. 264

DIGEST OF SB 264 (Updated February 26, 2018 6:34 pm - DI 131)

Citations Affected: IC 16-18; IC 16-21.

Synopsis: Rape kits. Defines "kit" as the standard medical forensic examination kit for victims of a sex crime developed by the state police department. Requires the statewide sexual assault response team advisory council (council) to prepare a report regarding: (1) the feasibility of creating a kit tracking and testing data base; (2) the identity of the supervising agency or entity responsible for creating, operating, managing, and maintaining the kit tracking and testing data base; and (3) possible sources of funding for the kit tracking and testing data base. Requires the council to submit a report to the legislative council in an electronic format not later than December 1, 2018. Defines certain terms. Makes conforming amendments.

Effective: July 1, 2018.

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:
