## SENATE BILL No. 265

DIGEST OF SB 265 (Updated January 29, 2014 7:17 pm - DI 71)

**Citations Affected:** IC 21-26.

**Synopsis:** Metropolitan campus governance. Defines "metropolitan campus". Requires the commission for higher education to designate Indiana University - Purdue University Fort Wayne as a metropolitan campus. Creates an advisory board for a metropolitan campus. Requires a governance agreement or an operational contract for a metropolitan campus to contain certain provisions.

**Effective:** July 1, 2014.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. A BILL FOR AN ACT to amend the Indiana Code concerning higher education.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 21-26-1-2.5 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2014]: **Sec. 2.5. "Board" refers to the metropolitan campus  
4 advisory board created under IC 21-26-5-5.**
- 5 SECTION 2. IC 21-26-1-4 IS ADDED TO THE INDIANA CODE  
6 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
7 1, 2014]: **Sec. 4. "Metropolitan campus" has the meaning set forth  
8 in IC 21-26-5-2.**
- 9 SECTION 3. IC 21-26-5 IS ADDED TO THE INDIANA CODE AS  
10 A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY  
11 1, 2014]:  
12 **Chapter 5. Metropolitan Campus Governance**  
13 **Sec. 1. As used in this chapter, "board" refers to the  
14 metropolitan campus advisory board created under section 5 of  
15 this chapter.**  
16 **Sec. 2. As used in this chapter, "metropolitan campus" refers to**

1 the regional campus designated by the commission for higher  
2 education under section 3 of this chapter.

3 **Sec. 3. The commission shall create the designation of**  
4 **"metropolitan campus" for Indiana University - Purdue University**  
5 **Fort Wayne.**

6 **Sec. 4. The commission shall apply the following to a**  
7 **metropolitan campus as a recognition of the metropolitan campus's**  
8 **unique character:**

9 (1) **A metropolitan campus may not have a cap on the amount**  
10 **of student housing allowed.**

11 (2) **A metropolitan campus may award doctoral degrees.**

12 **Sec. 5. (a) A metropolitan campus advisory board is created to**  
13 **provide information and advice for the governance of the**  
14 **metropolitan campus to the state educational institution that is the**  
15 **managing partner of the metropolitan campus.**

16 (b) **The chairperson of the board serves as a nonvoting member**  
17 **of the board of trustees of the state educational institution that is**  
18 **the managing partner of the metropolitan campus.**

19 **Sec. 6. The governance agreement or operational contract for**  
20 **a metropolitan campus shall include the following provisions:**

21 (1) **The metropolitan campus may not be required to receive**  
22 **approval from either operating state educational institution**  
23 **before submitting a proposal for a new degree or program to**  
24 **the commission under IC 21-18-9-5.**

25 (2) **The chancellor of the metropolitan campus must be**  
26 **allowed to deal directly with each operating state educational**  
27 **institution's board of trustees and may not be required to**  
28 **approach the board of trustees through the president of the**  
29 **operating state educational institution.**

30 (3) **Metropolitan campus faculty leaders must be recognized**  
31 **as part of each operating state educational institution's faculty**  
32 **leadership.**

33 (4) **Faculty members employed by each operating state**  
34 **educational institution must be included when seeking**  
35 **participation from metropolitan campus faculty members.**

36 (5) **Each metropolitan campus faculty member must have**  
37 **access to the resources of each operating state educational**  
38 **institution, regardless of the state educational institution by**  
39 **which the faculty member is employed.**

40 (6) **The administration or faculty of the metropolitan campus,**  
41 **as appropriate, must be allowed to select representatives of**  
42 **the regional campus who serve on systemwide committees of**



1           **the operating state educational institution.**  
2           **(7) A process must be established by which the metropolitan**  
3           **campus may choose not to participate in systemwide**  
4           **administrative tasks and systems, as appropriate.**
