

SENATE BILL No. 267

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-30-14.5.

Synopsis: Biliteracy. Establishes the state seal of biliteracy to recognize public school graduates who demonstrate a high level of proficiency in English and at least one other language. Requires the state board of education to adopt rules and to direct the department of education to administer the state seal of biliteracy program. Provides that a school corporation or charter school is not required to participate in the state seal of biliteracy program.

Effective: July 1, 2015.

SENATE BILL No. 267

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 20-30-14.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]:
4 **Chapter 14.5. State Seal of Bilingualism**
5 **Sec. 1. As used in this chapter, "foreign language" refers to any**
6 **language other than English, including:**
7 (1) **modern languages;**
8 (2) **Latin;**
9 (3) **American Sign Language;**
10 (4) **Native American languages; and**
11 (5) **native languages.**
12 **Sec. 2. As used in this chapter, "seal" refers to the state seal of**
13 **bilingualism created under section 3 of this chapter.**
14 **Sec. 3. (a) The state seal of bilingualism is created to:**
15 (1) **encourage students to study languages;**
16 (2) **certify the attainment of bilingualism;**



1 (3) provide employers with a method of identifying
2 individuals with language and biliteracy skills;

3 (4) provide postsecondary educational institutions with an
4 additional method to recognize applicants for admission;

5 (5) prepare students with twenty-first century skills;

6 (6) recognize the value of foreign language and native
7 language instruction in public schools; and

8 (7) strengthen intergroup relationships, affirm the value of
9 diversity, and honor the multiple cultures and languages of a
10 community.

11 (b) The seal certifies the attainment of a high level of proficiency
12 by a public high school graduate, sufficient for meaningful use in
13 college and a career, in one (1) or more languages in addition to
14 English.

15 (c) A school corporation or charter school is not required to
16 participate in the seal program.

17 Sec. 4. The state board shall:

18 (1) establish the criteria for earning a seal, including:

19 (A) the number of credits a student must earn in English
20 and language arts and in a language other than English;
21 and

22 (B) assessments of foreign language proficiency the state
23 board considers necessary;

24 (2) direct the department to prepare and deliver to
25 participating school corporations and charter schools an
26 appropriate mechanism for designating the seal on a student's
27 diploma and transcript indicating the student has been
28 awarded a seal; and

29 (3) direct the department to provide any other information
30 the state board considers necessary for school corporations
31 and charter schools to successfully participate in the seal
32 program.

33 Sec. 5. A participating school corporation or charter school
34 shall:

35 (1) maintain appropriate records to identify students who
36 have earned a seal; and

37 (2) make the appropriate designation on the diploma and
38 transcript of each student who earns a seal.

39 Sec. 6. (a) Except as provided in subsection (b), a student may
40 not be charged a fee to receive a seal under this chapter.

41 (b) If necessary, a student may be required to pay a fee to
42 demonstrate proficiency in a language, including the cost of a



1 **standardized test to determine proficiency.**
2 **Sec. 7. The state board shall adopt rules under IC 4-22-2 to**
3 **carry out this chapter.**
