**Synopsis:** Nondomiciled commercial driver's licenses. Requires the bureau of motor vehicles to issue nondomiciled commercial driver's licenses in accordance with federal regulations.

## SENATE BILL No. 275

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 9-24-6.1-10 IS ADDED TO THE INDIANA CODE  
2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2017]: **Sec. 10. (a) As used in this section, "nondomiciled  
4 commercial driver's license" means a commercial driver's license  
5 that is issued to an individual who is domiciled:**  
6 (1) in a foreign country meeting the requirements of 49 CFR  
7 383.23(b)(1); or  
8 (2) in another state meeting the requirements of 49 CFR  
9 383.23(b)(2).  
10 (b) The bureau shall issue a nondomiciled commercial driver's  
11 license in accordance with 49 CFR 383.23 to an individual who  
12 meets the requirements of 49 CFR 383.71(f).  
13 (c) The bureau may create an application form or other  
14 required documents to implement this section.  
15 (d) An individual who applies for a nondomiciled commercial  
16 driver's license must:  
17 (1) complete the requirements to receive a commercial

- 1           **driver's license under this chapter; and**
- 2           **(2) submit to the bureau upon application:**
- 3               **(A) an unexpired employment authorization document**
- 4               **(EAD) issued by the United States customs and**
- 5               **immigration services; or**
- 6               **(B) an unexpired foreign passport and an approved I-94**
- 7               **form documenting the applicant's most recent admittance**
- 8               **into the United States.**
- 9           **(e) The fee for a nondomiciled commercial driver's license is the**
- 10           **same as for a commercial driver's license under section 4 of this**
- 11           **chapter.**
- 12           **(f) A nondomiciled commercial driver's license is subject to the**
- 13           **same restrictions and requirements as a commercial driver's**
- 14           **license under this chapter.**
- 15           **(g) The bureau may adopt rules under IC 4-22-2 to implement**
- 16           **this section.**
