

SENATE BILL No. 275

DIGEST OF INTRODUCED BILL

Citations Affected: IC 14-23-4.5.

Synopsis: Old forest areas in state forests. Requires the department of natural resources (department), before January 1, 2019, to designate at least one undivided area comprising at least 30% of each state forest as an old forest area. Provides that, wherever possible, the size of a designated old forest area must be at least 500 acres. Sets forth certain purposes to guide the department in designating the old forest areas. Prohibits the department from conducting or allowing timber management in the old forest areas. Requires the department to produce and keep on file maps and legal descriptions of the designated old forest areas. Provides that the designation of the old forest areas may not affect hunting, fishing, and other recreational uses of the state forests, the maintenance of access roads in the state forests, or rights of access through the state forests.

Effective: July 1, 2018.

SENATE BILL No. 275

A BILL FOR AN ACT to amend the Indiana Code concerning natural resources.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 14-23-4.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2018]:

4 **Chapter 4.5. Old Forest Areas**
5 **Sec. 1. As used in this chapter, "timber management" includes**
6 **any of the following:**

- 7 (1) **Harvesting timber.**
- 8 (2) **Planting trees.**
- 9 (3) **Fertilization.**
- 10 (4) **Thinning of trees.**
- 11 (5) **Weeding.**

12 **Sec. 2. (a) Before January 1, 2019, in each state forest, the**
13 **department shall designate at least one (1) undivided area**
14 **comprising at least thirty percent (30%) of the state forest as an**
15 **old forest area.**

16 **(b) Wherever possible, the size of an old forest area designated**
17 **under this section must be at least five hundred (500) acres.**



1 **Sec. 3. In designating old forest areas under this chapter, the**
 2 **department shall be guided by the following purposes:**

- 3 **(1) Ensuring that state forests retain trees of age classes that**
 4 **cover the entire natural lifespans of Indiana's native trees.**
 5 **(2) Providing habitat for forest dependent wildlife species.**
 6 **(3) Protecting ecologically sensitive, geologically sensitive, or**
 7 **unique areas.**
 8 **(4) Protecting water resources.**
 9 **(5) Providing public recreational opportunities.**
 10 **(6) Maintaining and enhancing aesthetic value.**
 11 **(7) Providing control areas for purposes of:**
 12 **(A) assessing how forests are responding naturally to**
 13 **stresses; and**
 14 **(B) comparing managed forest stands and unmanaged**
 15 **forest stands over time as to productivity, regeneration,**
 16 **and species richness as a guide to logging in a sustainable**
 17 **manner.**

18 **Sec. 4. Beginning January 1, 2019, the department shall produce**
 19 **and keep on file maps and legal descriptions of the old forest areas**
 20 **designated in state forests under this chapter.**

21 **Sec. 5. The department shall not:**

- 22 **(1) conduct; or**
 23 **(2) allow;**

24 **timber management in the old forest areas designated in state**
 25 **forests under this chapter.**

26 **Sec. 6. The designation of old forest areas in state forests under**
 27 **this chapter may not affect the following:**

- 28 **(1) Hunting, fishing, trapping, and the gathering of edible and**
 29 **medicinal plants and mushrooms in the state forests, as**
 30 **permitted by law and administrative rules.**
 31 **(2) Recreational uses of the state forests, such as hiking,**
 32 **camping, horseback riding, and mountain biking, as**
 33 **permitted by law and administrative rules and allowed by**
 34 **state forest management programs.**
 35 **(3) The maintenance of access roads, lanes, and trails in the**
 36 **state forests.**
 37 **(4) Rights of access in existence on January 1, 2019, through**
 38 **the state forests to private property and cemeteries.**
 39 **(5) Methods of monitoring and controlling nonnative invasive**
 40 **species in the state forests other than through the harvesting**
 41 **of timber.**
 42 **(6) Providing emergency medical assistance in the state**

- 2 (7) Conducting search and rescue operations in the state
- 3 forests.
- 4 (8) Extinguishing or controlling fires in the state forests.
