

SENATE BILL No. 277

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-18-2-4; IC 20-26-5-36; IC 21-7-13-16; IC 28-2-13-22.6.

Synopsis: School counselors. Requires a school corporation to employ at least one school counselor at each elementary school, not including private or charter schools, maintained by the school corporation.

Effective: July 1, 2015.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-18-2-4, AS ADDED BY P.L. 1-2005, SECTION
2 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,
3 2015]: Sec. 4. **(a) Except as provided in subsection (b), "elementary**
4 **school" means any combination of kindergarten and grades 1, 2, 3, 4,**
5 **5, 6, 7, or 8.**

6 **(b) "Elementary school", for purposes of IC 20-26-5-36, means**
7 **any school with:**

- 8 **(1) only kindergarten; or**
- 9 **(2) a combination of kindergarten and grades 1, 2, 3, 4, 5, or**
10 **6.**

11 **The term does not include a private school or charter school.**

12 SECTION 2. IC 20-26-5-36 IS ADDED TO THE INDIANA CODE
13 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
14 1, 2015]: **Sec. 36. A school corporation shall employ at least one (1)**
15 **school counselor at each elementary school maintained by the**
16 **school corporation.**

 2 SECTION 243, IS AMENDED TO READ AS FOLLOWS
 3 [EFFECTIVE JULY 1, 2015]: Sec. 16. "Elementary school" has the
 4 meaning set forth in ~~IC 20-18-2-4~~. **IC 20-18-2-4(a).**

5 SECTION 4. IC 28-2-13-22.6, AS ADDED BY P.L.90-2008,
 6 SECTION 34, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 7 JULY 1, 2015]: Sec. 22.6. (a) As used in this chapter, "school" means:

8 (1) an elementary school (as defined in ~~IC 20-18-2-4~~);
 9 **IC 20-18-2-4(a)**; or

10 (2) a secondary school (as defined in IC 20-18-2-18).

11 The term includes a public school (as defined in IC 20-18-2-15) or a
 12 nonpublic school (as defined in IC 20-18-2-12).

13 (b) A state bank is entitled to establish an intermittent facility on the
 14 premises of a school in Indiana for the purpose of offering limited
 15 account services as an educational tool for students.

16 (c) The services that may be offered at an intermittent facility
 17 established under this section include:

18 (1) the opening of accounts;

19 (2) the acceptance of deposits; and

20 (3) other services determined by the department.

21 (d) To establish an intermittent facility under this section, a state
 22 bank is not required to submit an application to the department.
 23 However, before establishing an intermittent facility under this section,
 24 a state bank must:

25 (1) obtain the written permission of:

26 (A) the governing body of the school corporation, for a public
 27 school; or

28 (B) the equivalent authority for a nonpublic school;

29 for the establishment and operation of the facility on the premises
 30 of the school; and

31 (2) notify the department in writing of the intention of the state
 32 bank to establish the intermittent facility.

33 (e) A written notice provided to the department under subsection
 34 (d)(2) must:

35 (1) be in the form; and

36 (2) contain the information;

37 prescribed by the department.

38 (f) An intermittent facility operated by a state bank under this
 39 section:

40 (1) may be operated only during the school year; and

41 (2) must meet all other requirements of state law applying to state
 42 banks.
