DIGEST OF INTRODUCED BILL

Citations Affected: IC 6-1.1-12-14.

Synopsis: Assessed value cap for veteran's deduction. Increases the assessed value cap (from \$143,160 to \$195,600) that applies to the property tax deduction for a veteran who: (1) has a total disability; or (2) has at least a 10% disability and is at least 62 years of age.

Effective: March 1, 2014 (retroactive).

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 6-1.1-12-14, AS AMENDED BY P.L.293-2013(ts),
2	SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE

4	in subsection (c) and except as provided in section 40.5 of this chapter,
5	an individual may have the sum of twelve thousand four hundred eighty
6	dollars (\$12,480) deducted from the assessed value of the tangible
7	property that the individual owns (or the real property, mobile home
8	not assessed as real property, or manufactured home not assessed as
9	real property that the individual is buying under a contract that
10	provides that the individual is to pay property taxes on the real
11	property, mobile home, or manufactured home if the contract or a
12	memorandum of the contract is recorded in the county recorder's office)
13	if:
14	(1) the individual served in the military or naval forces of the
15	United States for at least ninety (00) days:

- 15 United States for at least ninety (90) days;
- 16 (2) the individual received an honorable discharge;

1	(3) the individual either:
2	(A) has a total disability; or
3	(B) is at least sixty-two (62) years old of age and has a
4	disability of at least ten percent (10%);
5	(4) the individual's disability is evidenced by:

8	(B) a certificate of eligibility issued to the individual by the

21	individual may receive the deduction provided by this section if the

23	at the time of death and the surviving spouse satisfies the requirement
24	of subsection $(a)(5)$ at the time the deduction statement is filed. The
25	surviving spouse is entitled to the deduction regardless of whether the
26	property for which the deduction is claimed was owned by the
27	deceased veteran or the surviving spouse before the deceased veteran's
28	death.
29	(c) No one is entitled to the deduction provided by this section if the
30	assessed value of the individual's tangible property, as shown by the tax
31	duplicate, exceeds one hundred forty-three thousand one hundred sixty
32	dollars (\$143,160). one hundred ninety-five thousand six hundred
33	dollars (\$195,600).
34	(d) An individual who has sold real property, a mobile home not
35	assessed as real property, or a manufactured home not assessed as real
36	property to another person under a contract that provides that the
37	contract buyer is to pay the property taxes on the real property, mobile
38	home, or manufactured home may not claim the deduction provided
39	under this section against that real property, mobile home, or
40	manufactured home.
