SENATE BILL No. 290

A BILL FOR AN ACT concerning civil procedure.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE JULY 1, 2014] (a) **As used in this**
2 **SECTION, "commission" refers to the commission on courts**
3 **established by IC 33-23-10-1.**
4 (b) **The general assembly urges the legislative council to assign**
5 **to the commission or another appropriate study committee the task**
6 **of studying medical debt collection in small claims courts.**
7 (c) **If the commission or another appropriate committee is**
8 **assigned the topic described in subsection (b), the commission or**
9 **committee shall issue to the legislative council a final report**
10 **containing the commission's or committee's findings and**
11 **recommendations, including any recommended legislation**
12 **concerning the topic, in an electronic format under IC 5-14-6 not**
13 **later than November 1, 2014.**
14 (d) **This SECTION expires January 1, 2015.**
