DIGEST OF INTRODUCED BILL

Citations Affected: IC 4-33-4-2.

Synopsis: Law enforcement and handguns in a casino. Prohibits the gaming commission from adopting a rule prohibiting a law enforcement officer from carrying a handgun in a casino, and repeals an existing rule. Permits the gaming commission to adopt rules: (1) requiring a law enforcement officer who is carrying a handgun to notify an enforcement agent that the law enforcement officer is carrying a handgun; and (2) prohibiting a law enforcement who is carrying a handgun from consuming alcohol or from entering a casino after having consumed alcohol.

Effective: July 1, 2020.
