ENGROSSED SENATE BILL No. 292

DIGEST OF SB 292 (Updated March 31, 2021 3:29 pm - DI 77)

Citations Affected: IC 16-18; IC 16-28.

Synopsis: Publication of health facility reporting. Requires the state department of health to compile case and death data related to COVID-19 reported by health facilities and residential care facilities in a specified manner and publish the information on the state department's Internet web site. Requires the state department to update the data at least every seven days. Provides that the reporting and publishing requirements expire April 1, 2022.

Effective: July 1, 2021.

(2) Update the information on the state department's Internet web site described in this section at least every seven (7) days."
