## **SENATE ENROLLED ACT No. 292**

AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 16-18-2-88.3 IS ADDED TO THE INDIANA CODE AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2021]: Sec. 88.3. "COVID-19", for purposes of IC 16-28-11-8, has the meaning set forth in IC 16-28-11-8(a).

SECTION 2. IC 16-18-2-317.7, AS AMENDED BY P.L.2-2019, SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2021]: Sec. 317.7. "Residential care facility", for purposes of IC 16-28-2, **IC 16-28-11-8**, and IC 16-32-5, means an entity licensed under IC 16-28 and registered as a housing with services establishment under IC 12-10-15.

SECTION 3. IC 16-28-11-8 IS ADDED TO THE INDIANA CODE AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2021]: Sec. 8. (a) As used in this section, "COVID-19" means:

(1) severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2); or

(2) the disease caused by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2).

(b) The state department shall compile case and death data related to COVID-19 that the state department requires to be reported by a health facility or a residential care facility licensed under this article to the state department. The state department shall do the following:

(1) Publish the information described in this section on the state department's Internet web site in a transparent and user friendly manner, and by specifying the data for each specific health facility, each residential care facility, and by each county.

(2) Update the information on the state department's Internet web site described in this section at least every seven (7) days.(c) This section expires April 1, 2022.
