ENGROSSED SENATE BILL No. 304

DIGEST OF SB 304 (Updated March 24, 2021 4:12 pm - DI 133)

Citations Affected: IC 5-16.

Synopsis: Indemnity agreements in public works contracts. Provides that a statute that invalidates indemnity agreements in construction contracts relating to providing certain professional services is applicable to such contracts relating to public works projects. Provides that a specified chapter does not apply to: (1) projects covered by INDOT's contractor qualification statute; or (2) a project that is the construction, improvement, alteration, repair, or maintenance of a highway, street, or road. Defines certain terms.

Effective: July 1, 2021.

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

Be it enacted by the General Assembly of the State of Indiana:

"Sec. 1. This chapter does not apply to a project covered by IC 8-23-10.".

Page 1, line 6, delete "1." and insert "2.".

Page 2, line 2, delete "2." and insert "3.".

Page 2, line 13, delete "3." and insert "4.".

Page 2, line 15, delete "4." and insert "5. (a)".

Page 2, between lines 17 and 18, begin a new paragraph and insert:

"(b) The term does not include a project that is the construction, improvement, alteration, repair, or maintenance of a highway, street, or road (as defined by IC 8-23-1-23).".

Page 2, line 18, delete "5." and insert "6.".
