ENGROSSED SENATE BILL No. 312

DIGEST OF SB 312 (Updated February 27, 2014 4:21 pm - DI 107)

Citations Affected: IC 4-30; IC 34-28.

Synopsis: Assignment of lottery prizes. Provides that a person who wins a prize payable in installments from the lottery commission may assign the future prize payments under certain circumstances upon court approval. Sets forth requirements for a court order approving a prize payment assignment. Requires that a petition to assign a prize payment must be served upon the lottery commission's director and the child support bureau. Requires the assignee to provide certain information. Requires the director of the lottery commission to investigate and certify whether a person who petitions for a lottery prize payment assignment has or has not satisfied debts to state agencies. Provides that if the Internal Revenue Service, the department of state revenue, or a court issues a determination or ruling that the voluntary assignment of a prize payment will affect federal income tax treatment, the commission shall file the determination or ruling with the attorney general's office and the Indiana judicial center, and a court may not issue a voluntary assignment of a prize payment after the date of the determination or ruling. Adds the department of child services to the list of agencies that must identify to the commission individuals who owe past due child support.

ENGROSSED SENATE BILL No. 312

A BILL FOR AN ACT to amend the Indiana Code concerning gaming.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 4-30-5-6 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2014]: **Sec. 6. If a person files a petition to assign a lottery prize
4 payment under IC 34-28-9.2 and the person has had debts to a
5 state agency, the director shall:**
6 **(1) investigate whether the person has any outstanding debts
7 to a state agency; and**
8 **(2) submit a letter, within fifteen (15) days after receiving the
9 petition, to the petitioner and the court in which the petition
10 is filed that:**
11 **(A) references the cause number of the petition to assign a
12 lottery prize payment; and**
13 **(B) states whether the person has or has not satisfied debts
14 to a state agency.**
15 SECTION 2. IC 4-30-11-2 IS AMENDED TO READ AS
16 FOLLOWS [EFFECTIVE JULY 1, 2014]: **Sec. 2. (a) Except as**

1 **provided in section 2.5 of this chapter**, the right of any person to a
 2 prize is not assignable.

3 (b) A prize may be paid to the estate of a deceased prize winner or
 4 to a person designated under an appropriate judicial order.

5 SECTION 3. IC 4-30-11-2.5 IS ADDED TO THE INDIANA CODE
 6 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 7 1, 2014]: **Sec. 2.5. (a) The right of a person to a prize is assignable
 8 if the prize is paid by the commission in installments over time.**

9 (b) A prize described in subsection (a) may be assigned, in whole
 10 or in part, if the assignment is made to a person or entity approved
 11 by a court based on a petition filed under IC 34-28-9.2.

12 (c) A prize payment may not be assigned to more than three (3)
 13 individuals or entities and a prize winner may not initiate more
 14 than three (3) assignment transactions in any single year.

15 (d) If more than one (1) person owns a prize payment, any
 16 assignment of the prize payment or payments must be made by
 17 each of the individuals who own the prize payment or payments.

18 (e) A prize payment or payments cannot be assigned until all
 19 debts listed in section 11 of this chapter are satisfied.

20 (f) A prize payment or any portion of a prize payment may not
 21 be assigned more than three (3) times unless the commission
 22 consents to an additional assignment. An assignment and
 23 reassignment of a prize payment or payments to one (1) individual
 24 or entity under a court order entered under a petition filed under
 25 IC 34-28-9.2 shall be considered a single assignment.

26 (g) The commission may charge a reasonable fee to the assignee
 27 to defray the cost of any administrative expenses associated with
 28 assignments approved by a court under IC 34-28-9.2. The fee may
 29 include the cost to the commission of a reasonable processing fee
 30 charged by a private annuity provider based on the direct and
 31 indirect costs of processing the assignment.

32 (h) A person who enters into a contract to assign a prize
 33 payment or payments under this section may cancel the contract
 34 assigning the person's prize payment or payments within three (3)
 35 business days after the date the contract assigning the prize
 36 payment or payments is signed.

37 (i) A contract assigning a prize payment or payments under this
 38 section and entered into before July 1, 2014, is unenforceable and
 39 invalid.

- 14 (1) owes an outstanding debt to a state agency;
- 15 (2) is on the department of state revenue's most recent tax warrant
 16 list; or
- 17 (3) owes **past due** child support collected and paid to a recipient
 18 through a court.

 21 **(b)**, the commission shall deduct the amount of the obligation from the
 22 prize money and transmit the deducted amount to the auditor of state.
 23 The commission shall pay the balance of the prize money to the prize
 24 winner after deduction of the obligation. If a prize winner owes
 25 multiple obligations subject to offset under this section and the prize is
 26 insufficient to cover all obligations, the amount of the prize shall be
 27 applied as follows:

- 28 (1) First, to the child support obligations **past due and** owed by
 29 the prize winner that are collected and paid to a recipient through
 30 a court.
- 31 (2) Second, to judgments owed by the prize winner.
- 32 (3) Third, to tax liens owed by the prize winner.
- 33 (4) Fourth, to unsecured debts owed by the prize winner **to a state**
 34 **agency.**

35 Within each of the categories described in subdivisions (1) through (4),
 36 the amount and priority of the prize shall be applied in the manner that
 37 the auditor of state determines to be appropriate. The commission shall
 38 reimburse the auditor of state pursuant to an agreement under
 39 IC 4-30-15-5 for the expenses incurred by the auditor of state in

6 **Sec. 1. (a) As set forth in IC 4-30-11-2.5, a person who has won**
7 **a prize from the state lottery commission created under IC 4-30-3**
8 **may file a verified petition with the Marion circuit court to**
9 **approve the assignment of a prize payment or payments.**

10 **(b) A verified petition filed under this section must include:**

11 **(1) statements that the person understands:**

12 **(A) the assignment of the prize payment or payments is**
13 **voluntary; and**

14 **(B) their right to solicit multiple bids for their prize**
15 **payments;**

16 **(2) a statement explaining to whom the prize payment or**
17 **payments would be assigned;**

18 **(3) a statement that the person is of sound mind, is in full**
19 **command of the person's faculties, and is not acting under**
20 **duress;**

21 **(4) a statement detailing that the person has had the**
22 **opportunity to receive or has received legal, financial, and tax**
23 **advice from a person or entity other than the person or entity**
24 **that would be assigned the prize payment or payments;**

25 **(5) a statement that the person understands that the person**
26 **will not receive the future payment or payments of the prize**
27 **after a prize payment or prize payments are assigned;**

28 **(6) a statement that the person understands that, with regard**
29 **to the assigned payments of the prize, the state lottery**
30 **commission and its employees are not liable to make any**
31 **future payments to the person that are subject to an**
32 **assignment made under IC 4-30-11-2.5;**

33 **(7) a statement that the person understands that the person**
34 **may cancel the contract assigning the person's prize payment**
35 **or payments within three (3) business days after the date the**
36 **contract assigning the prize payment or payments is signed;**

37 **(8) details of the proposed assignment, including:**

38 **(A) the amount of the prize payments assigned;**

39 **(B) the dates the prize payments are assigned;**

40 **(C) the purchase price of the prize payments assigned;**

41 **(D) the rate of discount to present value, assuming daily**
42 **compounding and funding on the contract date; and**



- 1 (E) the amount, if any, of any origination or closing fees
 2 charged to the person;
 3 (9) a statement detailing whether the person:
 4 (A) owes child support;
 5 (B) owes money as part of a judgment or garnishment;
 6 (C) has not satisfied an order for criminal restitution; or
 7 (D) owes any debt to an Indiana state agency that has
 8 provided written notice to the person regarding the debt;
 9 (10) a sworn affirmation that the contents of the petition are
 10 true; and
 11 (11) a statement that the person has had an adequate
 12 opportunity to receive multiple bids to assign their prize
 13 payment or payments.
- 14 **Sec. 2.** If a petition filed under section 1 of this chapter indicates
 15 that the petitioner has one (1) or more current child support
 16 obligations and the Title IV-D agency has entered an appearance:
 17 (1) the court shall consider ordering the petitioner to secure
 18 a bond under IC 31-16-3.5 for the purpose of insuring the
 19 future payment of child support obligations; and
 20 (2) if the purchase price of the payments assigned under
 21 section (1)(b)(8) is insufficient to secure a child support bond,
 22 then the court shall consider denying the petition.
- 23 **Sec. 3.** If a court finds that a prize payment or payments from
 24 the state lottery commission may be assigned based on a petition
 25 filed under section 1 of this chapter and IC 4-30-11-2.5, the court
 26 shall issue an order approving the prize payment assignment. The
 27 order must include a statement that the petitioner:
 28 (1) has filed a verified petition under section 1 of this chapter;
 29 (2) understands:
 30 (A) the assignment of the prize payment or payments is
 31 voluntary;
 32 (B) to whom the prize payment or payments will be
 33 assigned;
 34 (C) the person will not receive future payments that are
 35 subject to an assignment made under IC 4-30-11-2.5;
 36 (D) the state lottery commission and its employees are not
 37 liable to make any prize payments to the person that are
 38 assigned to another individual or entity under
 39 IC 4-30-11-2.5; and
 40 (E) that the person may cancel the contract assigning the
 41 person's prize payment or payments within three (3)
 42 business days after the date the contract assigning the



- 1 prize payment or payments is signed;
 2 (3) is of sound mind, is in full command of the person's
 3 faculties, and is not acting under duress;
 4 (4) has received or has had the opportunity to receive legal,
 5 financial, and tax advice from a person or entity other than
 6 the person or entity that would be assigned the prize payment
 7 or payments;
 8 (5) has no debts to state agencies or has satisfied all past debts
 9 to state agencies; and
 10 (6) has received, prior to signing the contract assigning the
 11 prize payment or payments, a written disclosure statement, on
 12 a separate piece of paper, in bold type with a font at least
 13 fourteen (14) points, stating the details of the proposed
 14 assignment, including:
 15 (A) the amount of the prize payment or payments assigned;
 16 (B) the dates of the prize payment or payments assigned;
 17 (C) the purchase price of the prize payment or payments
 18 assigned;
 19 (D) the rate of discount to present value, assuming daily
 20 compounding and funding on the contract date; and
 21 (E) the amount, if any, of any origination or closing fees
 22 charged to the person.
- 23 **Sec. 4. A person filing a petition under this chapter shall serve**
 24 **a copy of the petition on the state lottery commission's director and**
 25 **the child support bureau established by IC 31-25-3-1.**
- 26 **Sec. 5. If a court schedules a hearing on a petition filed under**
 27 **this chapter, the court shall notify the state lottery commission's**
 28 **director, the child support bureau established by IC 31-25-3-1, and**
 29 **the petitioner at least twenty (20) days before the hearing date.**
- 30 **Sec. 6. (a) The state lottery commission and the child support**
 31 **bureau established by IC 31-25-3-1 are not required to respond to**
 32 **a petition filed under this chapter.**
- 33 **(b) The state lottery commission and the child support bureau**
 34 **established by IC 31-25-3-1 may file a response to a petition filed**
 35 **under this chapter and may participate in any hearings, if any, on**
 36 **petitions filed under this chapter.**
- 37 **Sec. 7. If a court approves a prize payment assignment under**
 38 **this chapter, the court shall provide a copy of the order to the state**
 39 **lottery commission within twenty (20) days of the order being**
 40 **entered and at least thirty (30) days before the first assigned**
 41 **payment is to be made to the assignee.**
- 42 **Sec. 8. The person to whom a prize payment or payments from**

8 determination letter, revenue ruling, other public ruling of the
9 Internal Revenue Service, or a published decision to the
10 commission or any lottery winner, declaring that the voluntary
11 assignment of prizes will affect the federal income tax treatment of
12 a prize winner who does not assign the winner's prize payment or
13 payments, the state lottery commission shall file a copy of the
14 letter, ruling, or decision with the attorney general's office and the
15 Indiana judicial center. A court may not issue an order authorizing
16 a voluntary assignment of a prize after the date the ruling, letter,
17 or published decision is filed.

18 (b) If a determination letter, revenue ruling, other public ruling,
19 or published decision is issued under subsection (a), the Internal
20 Revenue Service or the court that issued the document shall send
21 a certified copy of the document to the director of the commission.

22 Sec. 10. If the department of state revenue issues a
23 determination, ruling, or finding to the commission or any lottery
24 winner declaring that the voluntary assignment of a prize will
25 reduce the state income tax due on the prize, the department of
26 state revenue shall file the determination, ruling, or finding with
27 the lottery commission, the attorney general's office, and the
28 Indiana judicial center. A court may not issue an order authorizing
29 a voluntary assignment of a prize after the date the determination,
30 ruling, or finding is filed.
