SENATE BILL No. 328

DIGEST OF SB 328 (Updated January 27, 2016 2:43 pm - DI 116)

Citations Affected: IC 21-13; IC 21-18.5.

Synopsis: Teacher assistance. Provides that individuals in a speech-language program are eligible to receive grants. Provides that grants are made subject to available resources. Provides that repayment of a grant shall be deferred if the commission for higher education determines that extenuating circumstances exist.

Effective: July 1, 2016.

SENATE BILL No. 328

A BILL FOR AN ACT to amend the Indiana Code concerning higher education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 21-13-11 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2016]:
4 **Chapter 11. Teacher Assistance Grants**
5 **Sec. 1. As used in this chapter, "cost of attendance" means the**
6 **annual tuition and mandatory fees.**
7 **Sec. 2. As used in this chapter, "grant" refers to a disbursement**
8 **made under section 4 of this chapter.**
9 **Sec. 3. As used in this chapter, "high needs subject area" means**
10 **an area determined annually by the department of education**
11 **established by IC 20-19-3-1 to have, or projected within the next**
12 **five (5) years to have, a shortage of licensed, full-time elementary**
13 **(as defined in IC 20-18-2-4) or high school (as defined in**
14 **IC 20-18-2-7) teachers or practitioners.**
15 **Sec. 4. (a) To qualify for a grant under this chapter, an**
16 **applicant must:**
17 **(1) be a resident of Indiana;**

1 **(2) enroll in an accredited teacher preparation or**
 2 **speech-language program in Indiana on a full-time or**
 3 **part-time basis:**

4 **(A) as an undergraduate student; or**

5 **(B) as a graduate student, if the department of education**
 6 **determines that there is a need for teachers with graduate**
 7 **degrees in a high needs subject area;**

8 **(3) specialize in a high needs subject area;**

9 **(4) agree in writing to obtain a license to teach under**
 10 **IC 20-28-5 and meet the employment requirements set forth**
 11 **in section 6 of this chapter;**

12 **(5) make satisfactory academic progress as determined by the**
 13 **postsecondary educational institution; and**

14 **(6) meet any additional criteria established by the**
 15 **commission.**

16 **(b) An individual who wishes to receive a grant must file an**
 17 **application with the commission in a timely fashion. The**
 18 **commission shall select grant recipients based on academic**
 19 **accomplishment and financial need, subject to resources available**
 20 **to fund the grant.**

21 **(c) If an applicant is selected to receive a grant, the commission**
 22 **may, subject to resources available to fund the grant, approve an**
 23 **annual grant in one (1) of the following amounts:**

24 **(1) For a full-time student, four thousand dollars (\$4,000) and**
 25 **fifty percent (50%) of the cost of attendance.**

26 **(2) For a part-time student, two thousand dollars (\$2,000) and**
 27 **twenty-five percent (25%) of the cost of attendance.**

28 **(d) An application to receive a grant must be renewed annually.**
 29 **An individual may receive a grant for a maximum of five (5) years.**

30 **(e) A grant under this chapter is in addition to an award**
 31 **received under IC 21-12, and may not be included as income in**
 32 **determining an award under IC 21-12. However, if receiving the**
 33 **cost of attendance portion of a grant would provide the grant**
 34 **recipient more than the actual cost of the grant recipient's tuition**
 35 **and mandatory fees when added to any awards received under**
 36 **IC 21-12, that portion of the grant shall be reduced to the amount**
 37 **that, when combined with awards received under IC 21-12, is**
 38 **necessary to pay only the actual cost of the grant recipient's tuition**
 39 **and fees.**

40 **(f) If, after a grant recipient has enrolled in a teacher**
 41 **preparation or speech-language program and is specializing in a**
 42 **subject area that is designated as a high needs subject area at the**



1 time of the grant recipient's enrollment, the department
 2 determines that the subject area in which the grant recipient is
 3 specializing is no longer a high needs subject area, the grant
 4 recipient may continue to receive grants if otherwise qualified to
 5 do so.

6 **Sec. 5. (a) After a grant recipient has completed a teacher**
 7 **preparation or speech-language program and obtained a license**
 8 **under IC 20-28-5, the grant recipient must:**

- 9 (1) obtain employment with a public school in Indiana; and
 10 (2) be employed by a public school in Indiana for a number of
 11 years that is equal to the number of years the grant recipient
 12 received a grant under this chapter. The grant recipient is not
 13 required to be employed by the same public school for the
 14 entire period.

15 (b) The building principal of the public school in which a grant
 16 recipient is employed shall verify the grant recipient's employment
 17 to the commission in the manner required by the commission.

18 **Sec. 6. (a) If a grant recipient fails to be employed by a public**
 19 **school in Indiana for a number of years that is equal to the number**
 20 **of years the grant recipient received a grant under this chapter, the**
 21 **grant recipient shall repay the commission an amount determined**
 22 **by the commission based upon the number of years the grant**
 23 **recipient was employed by a public school in Indiana.**

24 (b) If a grant recipient who fails to be employed by a public
 25 school submits a petition to the commission requesting deferment
 26 of repayment and the commission makes a determination that
 27 extenuating circumstances exist, the commission shall defer
 28 repayment of the grant.

29 **Sec. 7. An individual may receive a grant under this chapter**
 30 **only if an appropriation has been made to carry out the specific**
 31 **purposes of this chapter.**

32 **Sec. 8. The commission may adopt rules under IC 4-22-2**
 33 **necessary to carry out this chapter, including rules governing**
 34 **academic and financial qualifications and the enforcement of**
 35 **employment requirements.**

36 SECTION 2. IC 21-18.5-4-3, AS AMENDED BY P.L.46-2014,
 37 SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 38 JULY 1, 2016]: Sec. 3. For purposes of administering this chapter, the
 39 commission shall do the following:

- 40 (1) Prepare and supervise the issuance of public information
 41 concerning this chapter, IC 21-12-2, IC 21-12-3, IC 21-12-4, and
 42 IC 21-12-5.



- 1 (2) Prescribe the form and regulate the submission of applications
2 for higher education awards and the commission's programs.
- 3 (3) Conduct conferences and interviews with applicants as
4 appropriate.
- 5 (4) Determine the eligibility of applicants.
- 6 (5) Select qualified applicants.
- 7 (6) Determine annually the maximum higher education award
8 (IC 21-12-3) and freedom of choice award (IC 21-12-4), subject
9 to approval by the budget agency with review by the budget
10 committee.
- 11 (7) Determine the respective amounts of, and award, the
12 appropriate higher education awards, grants, and scholarships.
- 13 (8) Determine eligibility for, and award, annual renewals of
14 higher education awards, grants, and scholarships.
- 15 (9) Act as the designated state agency for participation in any
16 federal program for reinsurance of student loans.
- 17 (10) Receive federal funds made available to the commission for
18 awards, grants, and scholarships, and disburse these funds in the
19 manner prescribed by federal law.
- 20 (11) One (1) time every year, submit a report to the legislative
21 council that provides data and statistical information regarding
22 the number of individuals who received assistance under
23 IC 21-12-6 and IC 21-12-6.5. The report made to the legislative
24 council must be in an electronic format under IC 5-14-6.
- 25 (12) One (1) time every year, submit a report to the budget
26 committee that provides data and statistical information regarding
27 the number of individuals who received assistance under
28 IC 21-12, IC 21-13, and IC 21-14.
- 29 (13) Administer and determine the eligibility of applicants for,
30 and award amounts under, the teacher loan repayment program
31 established under IC 21-13-10.
- 32 **(14) Administer and determine the eligibility of applicants for,**
33 **and award grants under, the teacher assistance grant**
34 **program established under IC 21-13-11.**

Page 4, delete lines 21 through 27.

Page 4, line 28, delete "11." and insert "**8**".

Page 4, line 29, after "governing" insert "**academic and financial qualifications and**".

Renumber all SECTIONS consecutively.
