

SENATE BILL No. 328

DIGEST OF INTRODUCED BILL

Citations Affected: IC 21-13-8.

Synopsis: Minority student teaching stipend. Provides that a minority student who participates in a school administration internship as part of the student's graduate degree program is eligible to receive a stipend from the student teaching stipend for minorities.

Effective: July 1, 2014.

SENATE BILL No. 328

A BILL FOR AN ACT to amend the Indiana Code concerning higher education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 21-13-8-1, AS ADDED BY P.L.205-2013,
2 SECTION 329, IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2014]: Sec. 1. An individual may apply for a
4 stipend under this chapter if the individual:
5 (1) is a minority student;
6 (2) will participate in:
7 (A) student teaching as part of the student's degree
8 requirements; **or**
9 (B) **a school administration internship as part of the**
10 **student's graduate degree program;**
11 (3) has earned a cumulative grade point average upon entering
12 student teaching of at least 3.0 on a 4.0 scale, or its equivalent as
13 determined by the eligible institution; and
14 (4) meets any other minimum criteria established by the
15 commission.
16 SECTION 2. IC 21-13-8-2, AS ADDED BY P.L.205-2013,



- 1 SECTION 329, IS AMENDED TO READ AS FOLLOWS
2 [EFFECTIVE JULY 1, 2014]: Sec. 2. (a) A student who has applied for
3 the stipend under section 1 of this chapter and has been approved by
4 the commission may request payment of the stipend after
5 demonstrating that the student will engage in student teaching **or a**
6 **school administration internship** during the upcoming academic
7 term.
- 8 (b) The stipend may not exceed:
- 9 (1) for a student with a cumulative grade point average of at least
10 3.5 on a 4.0 scale, or its equivalent as determined by the eligible
11 institution, based on the most recently concluded academic term,
12 five thousand dollars (\$5,000); or
- 13 (2) for a student with a cumulative grade point average of at least
14 3.0 and less than 3.5 on a 4.0 scale, or its equivalent as
15 determined by the eligible institution, based on the most recently
16 concluded academic term, four thousand dollars (\$4,000).
- 17 (c) The commission shall pay the stipend directly to the student.
