SENATE BILL No. 332

DIGEST OF SB 332 (Updated January 18, 2018 11:26 am - DI 84)

Citations Affected: IC 12-10; IC 31-33; IC 34-30.

Synopsis: Protecting pets in distressed homes. Provides that: (1) an adult protective services unit conducting an investigation; or (2) a caseworker conducting an assessment; who observes, or has reason to believe, that an animal is a victim of animal cruelty, abandonment, or neglect may make a report to the local law enforcement agency or local animal control officer. Provides that: (1) an adult protective services unit; or (2) a caseworker; who makes a report of animal cruelty, abandonment, or neglect is immune from civil and criminal liability.

Effective: July 1, 2018.

A BILL FOR AN ACT to amend the Indiana Code concerning agriculture and animals.

Be it enacted by the General Assembly of the State of Indiana:

 19 **observes, or has reason to believe, that an animal is a victim of**
 20 **animal cruelty, abandonment, or neglect, the caseworker may**
 21 **make a report of the observed or suspected animal cruelty,**
 22 **abandonment, or neglect to:**

- 23 **(1) the local law enforcement agency; or**
 24 **(2) the local animal control officer.**

25 **(b) The information provided in a report under subsection (a)**
 26 **must include the following:**

- 27 **(1) A name and description of the animal and the animal's**
 28 **condition.**
 29 **(2) The name and contact number, if known, of the owner or**
 30 **custodian of the animal.**
 31 **(3) The address or location of the observed or suspected**
 32 **animal cruelty, abandonment, or neglect.**
 33 **(4) The nature and apparent extent of the observed or**
