DIGEST OF SB 333 (Updated February 14, 2023 9:15 am - DI 140)

Citations Affected: IC 22-15.

Synopsis: Rules governing certain construction inspections. Makes changes to the qualification requirements for an applicant of a design release issued by the state building commissioner.

Effective: July 1, 2023.

SENATE BILL No. 333

A BILL FOR AN ACT to amend the Indiana Code concerning labor and safety.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 22-15-3-2, AS AMENDED BY P.L.187-2021,
2	SECTION 100, IS AMENDED TO READ AS FOLLOWS
3	[EFFECTIVE JULY 1, 2023]: Sec. 2. To qualify for a design release
4	under this section, an applicant must:
5	(1) demonstrate, through the submission of plans and
6	specifications for the construction covered by the application, that
7	the construction will comply with all applicable building laws and
8	fire safety laws;
9	(2) pay the fees set under IC 22-12-6-6;
10	(3) have the plans and specifications:
11	(A) prepared by a registered architect or professional engineer
12	who is:
13	(i) competent to design the construction covered by the
14	application as determined by the department; and
15	(ii) registered under IC 25-4 or IC 25-31;
16	(B) include on each page of all drawings and the title page of
17	all specifications the seal of the registered architect or

1	professional engineer described by clause (A) or the person's
2	technical or professional staff; and
3	(C) filed by the registered architect or professional engineer
4	described by clause (A) or the person's technical or
5	professional staff; and
6	(4) submit a certificate prepared on a form provided by the
7	department and sworn or affirmed under penalty of perjury by the
8	registered architect or professional engineer described in
9	subdivision (3)(A):
10	(A) providing an estimate of the cost of the construction
1	covered by the application, its square footage, and any other
12	information required under the rules of the commission;
13	(B) stating that the plans and specifications submitted for the
14	application were prepared either by or under the immediate
15	supervision of the person making the statement;
16	(C) stating that the plans and specifications submitted for the
17	application provide for construction that will meet all building
18	laws; and
19	(D) stating that the construction covered by the application
20	will be subject to inspection in accordance with the rules
21	adopted by the commission under IC 4-22-2. at intervals
22	appropriate to the stage of the construction by a registered
23	architect or professional engineer identified in the statement
24	for the purpose of determining in general if work is proceeding
25	in accordance with the released plans and specifications.
