Citations Affected: IC 10-19.

Synopsis: Emergency notification systems. Requires the executive director of the department of homeland security to develop and implement protocols concerning the use of severe weather warning sirens.

Effective: July 1, 2014.

SENATE BILL No. 335

A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 10-19-3-3, AS AMENDED BY P.L.27-2010,
2 SECTION 4, IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2014]: Sec. 3. The executive director shall do
4 the following:
5 (1) Serve as the chief executive and administrative officer of
6 the department.
7 (2) Serve as the director of the council.
8 (3) Administer the application for, and disbursement of, federal
9 and state homeland security money for all Indiana state and
10 local governments.
11 (4) Develop a single strategic plan for preparing and
12 responding to homeland security emergencies in consultation
13 with the council.
14 (5) Serve as the state coordinating officer under federal law for
15 all matters relating to emergency and disaster mitigation,
16 preparedness, response, and recovery.

- 1 (6) Use and allocate the services, facilities, equipment,
- 2 personnel, and resources of any state agency, on the governor's
- 3 behalf, as is reasonably necessary in the preparation for,
- 4 response to, or recovery from an emergency or disaster
- 5 situation that threatens or has occurred in Indiana.
- 6 (7) Develop a plan to protect key state assets and public
- 7 infrastructure from a disaster or terrorist attack.
- 8 **(8) Not later than July 1, 2015, develop and implement**
- 9 **protocols for the appropriate and consistent usage of severe**
- 10 **weather warning sirens (as defined in IC 36-8-21.5-8)**
- 11 **throughout the state. The protocols shall include the**
- 12 **following:**
- 13 (A) Operational guidelines for the use of severe weather
- 14 warning sirens to signal severe weather.
- 15 (B) Public awareness education.
- 16 **This subdivision expires December 31, 2015.**
