### ENGROSSED SENATE BILL No. 342

DIGEST OF SB 342 (Updated February 14, 2022 10:47 am - DI 140)

Citations Affected: IC 14-28.

**Synopsis:** Flood plain management. Provides that in a county having a population within certain parameters, a local flood plain administrator may issue a variance allowing a structure located in a floodway to remain in its location without a permit issued by the director of the department of natural resources if the structure is an abode or residence, a permit for the construction of the abode or residence was issued by the appropriate official of the county before December 19, 2018, and other conditions are met.

Effective: Upon passage.

Be it enacted by the General Assembly of the State of Indiana:

#### COMMITTEE REPORT

Madam President: The Senate Committee on Natural Resources, to which was referred Senate Bill No. 342, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 1, delete lines 1 through 17.

Page 2, delete lines 1 through 29, begin a new paragraph and insert:

"SECTION 1. IC 14-28-1-22.3 IS ADDED TO THE INDIANA CODE AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 22.3. (a) This section applies to local flood plain administrators in a county having a population of more than sixty-five thousand (65,000) and less than sixty-six thousand six hundred (66,600).

(b) A local flood plain administrator may issue a variance allowing a structure located in a floodway to remain in its location without a permit issued by the director of the department under section 22 of this chapter if:

(1) the structure is an abode or residence;

(2) a permit for the construction of the abode or residence was issued by the appropriate official of the county in which the abode or residence was constructed;

(3) the permit was issued before December 19, 2018;

(4) the location of the abode or residence was not shown as being within a special flood hazard area or a Zone A in the Federal Emergency Management Agency Flood Insurance Rate Map that was available to the county official when the county official issued the permit; and

(5) the abode or residence was built in compliance with the permit.

(c) This section expires July 1, 2023.".
