DIGEST OF INTRODUCED BILL

Citations Affected: IC 24-4.7.

Synopsis: Telephone solicitations. Amends the statute governing telephone solicitations of consumers (Indiana's "do not call" statute) to provide that certain prohibitions that apply to telephone solicitors also apply to: (1) suppliers in consumer transactions; and (2) sellers engaging in telephone solicitations. Adds a new prohibition to provide that a telephone solicitor, a supplier, or a seller may not sell, transfer, or make available to another person for solicitation purposes a consumer's telephone number if: (1) the telephone number appears in the most current "do not call" listing; or (2) the consumer: (A) has previously requested not to receive telephone sales calls from a solicitor, a supplier, or a seller; and (B) has not rescinded that request. A BILL FOR AN ACT to amend the Indiana Code concerning trade regulation.

Be it enacted by the General Assembly of the State of Indiana:

A telephone solicitor, a supplier, or a seller 32 who fails to comply with any provision of IC 24-4.7-4 commits a 33 deceptive act that is actionable by the attorney general under this 34 chapter. In addition, a contractor who contracts or seeks to contract 35 with the state: 36 (1) may be prohibited from contracting with the state; or 37 (2) may have an existing contract with the state voided; 38 if the contractor, an affiliate or principal of the contractor, or any agent 39 acting on behalf of the contractor or an affiliate or principal of the 40 contractor does not or has not complied with the terms of this article, 41 even if this article is preempted by federal law.
