Synopsis: Interim study committee on communities. Establishes the interim study committee on communities to review and study during the 2014 legislative interim certain issues relating to the economic vitality of communities.

A BILL FOR AN ACT to amend the Indiana Code concerning the general assembly.

Be it enacted by the General Assembly of the State of Indiana:
