#### **SENATE BILL No. 361**

DIGEST OF SB 361 (Updated January 22, 2018 11:15 am - DI 84)

Citations Affected: IC 2-5.

**Synopsis:** Water infrastructure task force. Establishes a water infrastructure task force (task force) consisting of two members of the senate, two members of the house of representatives, and five governor's appointees, one of whom the governor shall appoint to serve as chair of the task force. Requires the task force to: (1) study drinking water systems and wastewater management systems; and (2) develop a long term plan for addressing drinking water and wastewater needs in Indiana. Requires the Indiana Finance Authority to provide staff support to the task force. Requires the task force to submit a report containing certain recommendations to the general assembly and the governor not later than December 1, 2018.

Effective: Upon passage.

## SENATE BILL No. 361

A BILL FOR AN ACT to amend the Indiana Code concerning environmental law.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 2-5-41 IS ADDED TO THE INDIANA CODE AS
2	A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE UPON
3	PASSAGE]:
4	Chapter 41. Water Infrastructure Task Force
5	Sec. 1. As used in this chapter, "task force" refers to the water
6	infrastructure task force established by section 2 of this chapter.
7	Sec. 2. The water infrastructure task force is established.
8	Sec. 3. The task force consists of the following members:
9	(1) Two (2) members of the senate, of whom:
10	(A) one (1) shall be appointed by the president pro
11	tempore; and
12	(B) one (1) shall be appointed by the minority leader.
13	(2) Two (2) members of the house of representatives, of
14	whom:
15	(A) one (1) shall be appointed by the speaker; and
16	(B) one (1) shall be appointed by the minority leader.
17	(3) Five (5) members appointed by the governor.

1	Sec. 4. (a) The governor shall appoint one (1) member appointed
2	under section 3(3) of this chapter as chair of the task force.
3	(b) The task force shall meet at the call of the chair.
4	Sec. 5. (a) A majority of the members of the task force constitute
5	a quorum.
6	(b) The affirmative vote of at least a majority of the members of
7	the task force is necessary for the task force to take official action
8	other than to meet and take testimony.
9	Sec. 6. The task force shall do the following:
10	(1) Review public and private studies and reports on Indiana's
11	water and wastewater systems.
12	(2) Assess the value of Indiana's water and wastewater
13	systems to the economy of the state.
14	(3) Examine recommended standards and best practices for
15	the maintenance and life cycle management of:
16	(A) drinking water systems; and
17	(B) wastewater management systems.
18	(4) Analyze whether individual:
19	(A) drinking water systems; and
20	(B) wastewater management systems;
21	in Indiana are achieving the recommended standards referred
22	to in subdivision (3).
23	(5) Assess the adequacy of present sources of funding for the
24	maintenance and life cycle management of:
25	(A) drinking water systems; and
26	(B) wastewater management systems;
27	and, if necessary, identify additional sources of funding.
28	(6) Evaluate whether, considering:
29	(A) the availability of resources;
30	(B) the ownership of resources;
31	(C) changing population demographics;
32	(D) appropriate system capacity;
33	(E) operational expertise;
34	(F) public health and safety; and
35	(G) economic development;
36	the regionalization of water infrastructure could improve
37	system performance and ratepayer value.
38	(7) Assess the extent to which an improved system of water
39	infrastructure would enhance economic development in
40	Indiana.
41	Sec. 7. The task force shall develop a long term plan for
42	addressing drinking water and wastewater needs in Indiana. The

1	long term plan must include recommendations to the general
2	assembly and the governor concerning the following:
3	(1) Outcomes that must be achieved in order to overcome
4	challenges facing Indiana's local water infrastructure, and the
5	benchmarks and timelines that must be met in order to
6	achieve these outcomes.
7	(2) Metrics to be used in assessing the current status of:
8	(A) drinking water systems; and
9	(B) wastewater management systems;
10	and in tracking the progress made toward accomplishing all
11	goals, benchmarks, and recommended standards.
12	(3) Funding and financing mechanisms that should be used to
13	achieve necessary improvements in:
14	(A) drinking water systems; and
15	(B) wastewater management systems.
16	(4) A determination of who should bear the financial burden
17	of improving:
18	(A) drinking water systems; and
19	(B) wastewater management systems;
20	and how the financial burden should be apportioned among
21	those bearing the financial burden.
22	(5) The definition of proper roles and responsibilities for all
23	state agencies involved in regulating, financing, or managing
24	of:
25	(A) drinking water systems; and
26	(B) wastewater management systems.
27	(6) Appropriate legislation for the 2019 legislative session
28	based on the recommendations made under subdivisions (1)
29	through (5).
30	Sec. 8. The task force shall:
31	(1) issue a report setting forth the recommendations made
32	under section 7 of this chapter; and
33	(2) not later than December 1, 2018, submit the report:
34	(A) in an electronic format under IC 5-14-6 to the
35	executive director of the legislative services agency for
36	distribution to the members of the general assembly; and
37	(B) to the governor.
38	Sec. 9. The Indiana finance authority shall provide staff support
39	to the task force.
40	Sec. 10. This chapter expires January 1, 2019.
41	SECTION 2. An emergency is declared for this act.
