## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 12-7-2-140.5; IC 12-15-47.

**Synopsis:** Medicaid based statewide health plan. Establishes the Indiana statewide health plan within the Medicaid program. Sets forth requirements of the plan. Requires the office of the secretary of the family and social services administration to apply for any federal waivers required for the plan.

**Effective:** July 1, 2018.

# SENATE BILL No. 378

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 12-7-2-140.5, AS AMENDED BY P.L.30-2016,  
2 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2018]: Sec. 140.5. "Plan" **means the following:**

4 (1) For purposes of IC 12-15-44.2 and IC 12-15-44.5, ~~has~~ the  
5 meaning set forth in IC 12-15-44.5-2.

6 (2) **For purposes of IC 12-15-47, the meaning set forth in**  
7 **IC 12-15-47-1.**

8 SECTION 2. IC 12-15-47 IS ADDED TO THE INDIANA CODE  
9 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
10 JULY 1, 2018]:

11 **Chapter 47. Indiana Statewide Health Plan**

12 **Sec. 1. As used in this chapter, "plan" refers to the Indiana**  
13 **statewide health plan established under section 2 of this chapter.**

14 **Sec. 2. (a) To the extent allowed by federal law, the office shall**  
15 **establish the Indiana statewide health plan within the Medicaid**  
16 **program and make coverage available for purchase through the**  
17 **plan to an individual who is not otherwise eligible for Medicaid.**



- 1           **(b) The coverage provided under the plan must meet the**
- 2 **following requirements:**
- 3           **(1) Provide the coverage required under the healthy Indiana**
- 4 **plan by IC 12-15-44.2.**
- 5           **(2) If the coverage is provided through an American health**
- 6 **benefit exchange operated in Indiana under the federal**
- 7 **Patient Protection and Affordable Care Act, be a qualified**
- 8 **health plan (as defined in 42 U.S.C. 18021).**
- 9           **(3) Allow an individual who is eligible for a premium tax**
- 10 **credit or a cost-sharing reduction under 45 CFR 155.305 to**
- 11 **use any credits or reductions to purchase plan coverage.**
- 12           **Sec. 3. (a) The office shall apply to the United States Department**
- 13 **of Health and Human Services for any waiver required to**
- 14 **implement or administer this chapter.**
- 15           **(b) If a waiver described in subsection (a) is approved, the office**
- 16 **shall implement the plan not later than July 1, 2020.**
- 17           **Sec. 4. The office may adopt rules under IC 4-22-2 necessary to**
- 18 **implement and administer this chapter.**
