DIGEST OF SB 380 (Updated March 24, 2015 1:28 pm - DI 107)

Citations Affected: IC 5-2.

Synopsis: Crisis intervention teams. Requires the law enforcement training academy to include an overview of crisis intervention team (CIT) training model in initial training. Establishes the Indiana technical assistance center for crisis intervention teams to: (1) identify grants and other funds that may be used to fund CIT programs; (2) create and support a statewide CIT advisory committee; and (3) provide training, information, and technical assistance.

ENGROSSED SENATE BILL No. 380

A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 5-2-1-2, AS AMENDED BY P.L.197-2011,
2 SECTION 26, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]: Sec. 2. For the purposes of this chapter, and unless the
4 context clearly denotes otherwise, the following definitions apply
5 throughout this chapter:
6 (1) "Law enforcement officer" means an appointed officer or
7 employee hired by and on the payroll of the state, any of the
8 state's political subdivisions, or a public or private postsecondary
9 educational institution whose board of trustees has established a
10 police department under IC 21-17-5-2 or IC 21-39-4-2 who is
11 granted lawful authority to enforce all or some of the penal laws
12 of the state of Indiana and who possesses, with respect to those
13 laws, the power to effect arrests for offenses committed in the
14 officer's or employee's presence. However, the following are
15 expressly excluded from the term "law enforcement officer" for
16 the purposes of this chapter:

- 1 (A) A constable.
 2 (B) A special officer whose powers and duties are described
 3 in IC 36-8-3-7 or a special deputy whose powers and duties are
 4 described in IC 36-8-10-10.6.
 5 (C) A county police reserve officer who receives compensation
 6 for lake patrol duties under IC 36-8-3-20(f)(4).
 7 (D) A conservation reserve officer who receives compensation
 8 for lake patrol duties under IC 14-9-8-27.
 9 (E) An employee of the gaming commission whose powers
 10 and duties are described in IC 4-32.2-9.
 11 (F) A correctional police officer described in IC 11-8-9.
 12 (2) "Board" means the law enforcement training board created by
 13 this chapter.
 14 (3) "Executive training program" means the police chief executive
 15 training program developed by the board under section 9 of this
 16 chapter.
 17 (4) "Law enforcement training council" means one (1) of the
 18 confederations of law enforcement agencies recognized by the
 19 board and organized for the sole purpose of sharing training,
 20 instructors, and related resources.
 21 (5) "Training regarding the lawful use of force" includes
 22 classroom and skills training in the proper application of hand to
 23 hand defensive tactics, use of firearms, and other methods of:
 24 (A) overcoming unlawful resistance; or
 25 (B) countering other action that threatens the safety of the
 26 public or a law enforcement officer.
 27 (6) "Hiring or appointing authority" means:
 28 (A) the chief executive officer, board, or other entity of a
 29 police department or agency with authority to appoint and hire
 30 law enforcement officers; or
 31 (B) the governor, mayor, board, or other entity with the
 32 authority to appoint a chief executive officer of a police
 33 department or agency.
 34 **(7) "Crisis intervention team" refers to a local coalition with**
 35 **a goal of improving the manner in which law enforcement and**
 36 **the community respond to crisis situations in which an**
 37 **individual is experiencing a mental health or addictive**
 38 **disorder crisis.**
 39 SECTION 2. IC 5-2-1-9, AS AMENDED BY P.L.164-2014,
 40 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 41 JULY 1, 2015]: Sec. 9. (a) The board shall adopt in accordance with
 42 IC 4-22-2 all necessary rules to carry out the provisions of this chapter.



1 The rules, which shall be adopted only after necessary and proper
2 investigation and inquiry by the board, shall include the establishment
3 of the following:

4 (1) Minimum standards of physical, educational, mental, and
5 moral fitness which shall govern the acceptance of any person for
6 training by any law enforcement training school or academy
7 meeting or exceeding the minimum standards established
8 pursuant to this chapter.

9 (2) Minimum standards for law enforcement training schools
10 administered by towns, cities, counties, law enforcement training
11 centers, agencies, or departments of the state.

12 (3) Minimum standards for courses of study, attendance
13 requirements, equipment, and facilities for approved town, city,
14 county, and state law enforcement officer, police reserve officer,
15 and conservation reserve officer training schools.

16 (4) Minimum standards for a course of study on cultural diversity
17 awareness, including training on the U nonimmigrant visa created
18 through the federal Victims of Trafficking and Violence
19 Protection Act of 2000 (P.L. 106-386) that must be required for
20 each person accepted for training at a law enforcement training
21 school or academy. Cultural diversity awareness study must
22 include an understanding of cultural issues related to race,
23 religion, gender, age, domestic violence, national origin, and
24 physical and mental disabilities.

25 (5) Minimum qualifications for instructors at approved law
26 enforcement training schools.

27 (6) Minimum basic training requirements which law enforcement
28 officers appointed to probationary terms shall complete before
29 being eligible for continued or permanent employment.

30 (7) Minimum basic training requirements which law enforcement
31 officers appointed on other than a permanent basis shall complete
32 in order to be eligible for continued employment or permanent
33 appointment.

34 (8) Minimum basic training requirements which law enforcement
35 officers appointed on a permanent basis shall complete in order
36 to be eligible for continued employment.

37 (9) Minimum basic training requirements for each person
38 accepted for training at a law enforcement training school or
39 academy that include six (6) hours of training in interacting with:

40 (A) persons with autism, mental illness, addictive disorders,
41 mental retardation, and developmental disabilities;

42 (B) missing endangered adults (as defined in IC 12-7-2-131.3);



- 1 and
 2 (C) persons with Alzheimer's disease or related senile
 3 dementia;
 4 to be provided by persons approved by the secretary of family and
 5 social services and the board. **The training must include an
 6 overview of the crisis intervention team model as developed
 7 under IC 5-2-21-6(2).**
 8 (10) Minimum standards for a course of study on human and
 9 sexual trafficking that must be required for each person accepted
 10 for training at a law enforcement training school or academy and
 11 for inservice training programs for law enforcement officers. The
 12 course must cover the following topics:
 13 (A) Examination of the human and sexual trafficking laws
 14 (IC 35-42-3.5).
 15 (B) Identification of human and sexual trafficking.
 16 (C) Communicating with traumatized persons.
 17 (D) Therapeutically appropriate investigative techniques.
 18 (E) Collaboration with federal law enforcement officials.
 19 (F) Rights of and protections afforded to victims.
 20 (G) Providing documentation that satisfies the Declaration of
 21 Law Enforcement Officer for Victim of Trafficking in Persons
 22 (Form I-914, Supplement B) requirements established under
 23 federal law.
 24 (H) The availability of community resources to assist human
 25 and sexual trafficking victims.
 26 (b) A law enforcement officer appointed after July 5, 1972, and
 27 before July 1, 1993, may not enforce the laws or ordinances of the state
 28 or any political subdivision unless the officer has, within one (1) year
 29 from the date of appointment, successfully completed the minimum
 30 basic training requirements established under this chapter by the board.
 31 If a person fails to successfully complete the basic training
 32 requirements within one (1) year from the date of employment, the
 33 officer may not perform any of the duties of a law enforcement officer
 34 involving control or direction of members of the public or exercising
 35 the power of arrest until the officer has successfully completed the
 36 training requirements. This subsection does not apply to any law
 37 enforcement officer appointed before July 6, 1972, or after June 30,
 38 1993.
 39 (c) Military leave or other authorized leave of absence from law
 40 enforcement duty during the first year of employment after July 6,
 41 1972, shall toll the running of the first year, which shall be calculated
 42 by the aggregate of the time before and after the leave, for the purposes



1 of this chapter.

2 (d) Except as provided in subsections (e), (l), (r), and (s), a law
3 enforcement officer appointed to a law enforcement department or
4 agency after June 30, 1993, may not:

- 5 (1) make an arrest;
6 (2) conduct a search or a seizure of a person or property; or
7 (3) carry a firearm;

8 unless the law enforcement officer successfully completes, at a board
9 certified law enforcement academy or at a law enforcement training
10 center under section 10.5 or 15.2 of this chapter, the basic training
11 requirements established by the board under this chapter.

12 (e) This subsection does not apply to:

- 13 (1) a gaming agent employed as a law enforcement officer by the
14 Indiana gaming commission; or
15 (2) an:
16 (A) attorney; or
17 (B) investigator;
18 designated by the securities commissioner as a police officer of
19 the state under IC 23-19-6-1(k).

20 Before a law enforcement officer appointed after June 30, 1993,
21 completes the basic training requirements, the law enforcement officer
22 may exercise the police powers described in subsection (d) if the
23 officer successfully completes the pre-basic course established in
24 subsection (f). Successful completion of the pre-basic course authorizes
25 a law enforcement officer to exercise the police powers described in
26 subsection (d) for one (1) year after the date the law enforcement
27 officer is appointed.

28 (f) The board shall adopt rules under IC 4-22-2 to establish a
29 pre-basic course for the purpose of training:

- 30 (1) law enforcement officers;
31 (2) police reserve officers (as described in IC 36-8-3-20); and
32 (3) conservation reserve officers (as described in IC 14-9-8-27);

33 regarding the subjects of arrest, search and seizure, the lawful use of
34 force, interacting with individuals with autism, and the operation of an
35 emergency vehicle. The pre-basic course must be offered on a periodic
36 basis throughout the year at regional sites statewide. The pre-basic
37 course must consist of at least forty (40) hours of course work. The
38 board may prepare the classroom part of the pre-basic course using
39 available technology in conjunction with live instruction. The board
40 shall provide the course material, the instructors, and the facilities at
41 the regional sites throughout the state that are used for the pre-basic
42 course. In addition, the board may certify pre-basic courses that may be



1 conducted by other public or private training entities, including
2 postsecondary educational institutions.

3 (g) The board shall adopt rules under IC 4-22-2 to establish a
4 mandatory inservice training program for police officers. After June 30,
5 1993, a law enforcement officer who has satisfactorily completed basic
6 training and has been appointed to a law enforcement department or
7 agency on either a full-time or part-time basis is not eligible for
8 continued employment unless the officer satisfactorily completes the
9 mandatory inservice training requirements established by rules adopted
10 by the board. Inservice training must include training in interacting
11 with persons with mental illness, addictive disorders, mental
12 retardation, autism, developmental disabilities, and Alzheimer's disease
13 or related senile dementia, to be provided by persons approved by the
14 secretary of family and social services and the board, and training
15 concerning human and sexual trafficking and high risk missing persons
16 (as defined in IC 5-2-17-1). The board may approve courses offered by
17 other public or private training entities, including postsecondary
18 educational institutions, as necessary in order to ensure the availability
19 of an adequate number of inservice training programs. The board may
20 waive an officer's inservice training requirements if the board
21 determines that the officer's reason for lacking the required amount of
22 inservice training hours is due to either of the following:

23 (1) An emergency situation.

24 (2) The unavailability of courses.

25 (h) The board shall also adopt rules establishing a town marshal
26 basic training program, subject to the following:

27 (1) The program must require fewer hours of instruction and class
28 attendance and fewer courses of study than are required for the
29 mandated basic training program.

30 (2) Certain parts of the course materials may be studied by a
31 candidate at the candidate's home in order to fulfill requirements
32 of the program.

33 (3) Law enforcement officers successfully completing the
34 requirements of the program are eligible for appointment only in
35 towns employing the town marshal system (IC 36-5-7) and having
36 not more than one (1) marshal and two (2) deputies.

37 (4) The limitation imposed by subdivision (3) does not apply to an
38 officer who has successfully completed the mandated basic
39 training program.

40 (5) The time limitations imposed by subsections (b) and (c) for
41 completing the training are also applicable to the town marshal
42 basic training program.



- 1 (6) The program must require training in interacting with
2 individuals with autism.
- 3 (i) The board shall adopt rules under IC 4-22-2 to establish an
4 executive training program. The executive training program must
5 include training in the following areas:
- 6 (1) Liability.
7 (2) Media relations.
8 (3) Accounting and administration.
9 (4) Discipline.
10 (5) Department policy making.
11 (6) Lawful use of force.
12 (7) Department programs.
13 (8) Emergency vehicle operation.
14 (9) Cultural diversity.
- 15 (j) A police chief shall apply for admission to the executive training
16 program within two (2) months of the date the police chief initially
17 takes office. A police chief must successfully complete the executive
18 training program within six (6) months of the date the police chief
19 initially takes office. However, if space in the executive training
20 program is not available at a time that will allow completion of the
21 executive training program within six (6) months of the date the police
22 chief initially takes office, the police chief must successfully complete
23 the next available executive training program that is offered after the
24 police chief initially takes office.
- 25 (k) A police chief who fails to comply with subsection (j) may not
26 continue to serve as the police chief until completion of the executive
27 training program. For the purposes of this subsection and subsection
28 (j), "police chief" refers to:
- 29 (1) the police chief of any city;
30 (2) the police chief of any town having a metropolitan police
31 department; and
32 (3) the chief of a consolidated law enforcement department
33 established under IC 36-3-1-5.1.
- 34 A town marshal is not considered to be a police chief for these
35 purposes, but a town marshal may enroll in the executive training
36 program.
- 37 (l) A fire investigator in the division of fire and building safety
38 appointed after December 31, 1993, is required to comply with the
39 basic training standards established under this chapter.
- 40 (m) The board shall adopt rules under IC 4-22-2 to establish a
41 program to certify handgun safety courses, including courses offered
42 in the private sector, that meet standards approved by the board for



1 training probation officers in handgun safety as required by
2 IC 11-13-1-3.5(3).

3 (n) The board shall adopt rules under IC 4-22-2 to establish a
4 refresher course for an officer who:

5 (1) is hired by an Indiana law enforcement department or agency
6 as a law enforcement officer;

7 (2) has not been employed as a law enforcement officer for at
8 least two (2) years and less than six (6) years before the officer is
9 hired under subdivision (1) due to the officer's resignation or
10 retirement; and

11 (3) completed at any time a basic training course certified by the
12 board before the officer is hired under subdivision (1).

13 (o) The board shall adopt rules under IC 4-22-2 to establish a
14 refresher course for an officer who:

15 (1) is hired by an Indiana law enforcement department or agency
16 as a law enforcement officer;

17 (2) has not been employed as a law enforcement officer for at
18 least six (6) years and less than ten (10) years before the officer
19 is hired under subdivision (1) due to the officer's resignation or
20 retirement;

21 (3) is hired under subdivision (1) in an upper level policymaking
22 position; and

23 (4) completed at any time a basic training course certified by the
24 board before the officer is hired under subdivision (1).

25 A refresher course established under this subsection may not exceed
26 one hundred twenty (120) hours of course work. All credit hours
27 received for successfully completing the police chief executive training
28 program under subsection (i) shall be applied toward the refresher
29 course credit hour requirements.

30 (p) Subject to subsection (q), an officer to whom subsection (n) or
31 (o) applies must successfully complete the refresher course described
32 in subsection (n) or (o) not later than six (6) months after the officer's
33 date of hire, or the officer loses the officer's powers of:

34 (1) arrest;

35 (2) search; and

36 (3) seizure.

37 (q) A law enforcement officer who has worked as a law enforcement
38 officer for less than twenty-five (25) years before being hired under
39 subsection (n)(1) or (o)(1) is not eligible to attend the refresher course
40 described in subsection (n) or (o) and must repeat the full basic training
41 course to regain law enforcement powers. However, a law enforcement
42 officer who has worked as a law enforcement officer for at least



1 twenty-five (25) years before being hired under subsection (n)(1) or
 2 (o)(1) and who otherwise satisfies the requirements of subsection (n)
 3 or (o) is not required to repeat the full basic training course to regain
 4 law enforcement power but shall attend the refresher course described
 5 in subsection (n) or (o) and the pre-basic training course established
 6 under subsection (f).

7 (r) This subsection applies only to a gaming agent employed as a
 8 law enforcement officer by the Indiana gaming commission. A gaming
 9 agent appointed after June 30, 2005, may exercise the police powers
 10 described in subsection (d) if:

11 (1) the agent successfully completes the pre-basic course
 12 established in subsection (f); and

13 (2) the agent successfully completes any other training courses
 14 established by the Indiana gaming commission in conjunction
 15 with the board.

16 (s) This subsection applies only to a securities enforcement officer
 17 designated as a law enforcement officer by the securities
 18 commissioner. A securities enforcement officer may exercise the police
 19 powers described in subsection (d) if:

20 (1) the securities enforcement officer successfully completes the
 21 pre-basic course established in subsection (f); and

22 (2) the securities enforcement officer successfully completes any
 23 other training courses established by the securities commissioner
 24 in conjunction with the board.

25 (t) As used in this section, "upper level policymaking position"
 26 refers to the following:

27 (1) If the authorized size of the department or town marshal
 28 system is not more than ten (10) members, the term refers to the
 29 position held by the police chief or town marshal.

30 (2) If the authorized size of the department or town marshal
 31 system is more than ten (10) members but less than fifty-one (51)
 32 members, the term refers to:

33 (A) the position held by the police chief or town marshal; and

34 (B) each position held by the members of the police
 35 department or town marshal system in the next rank and pay
 36 grade immediately below the police chief or town marshal.

37 (3) If the authorized size of the department or town marshal
 38 system is more than fifty (50) members, the term refers to:

39 (A) the position held by the police chief or town marshal; and

40 (B) each position held by the members of the police
 41 department or town marshal system in the next two (2) ranks
 42 and pay grades immediately below the police chief or town



1 marshal.

2 (u) This subsection applies only to a correctional police officer
3 employed by the department of correction. A correctional police officer
4 may exercise the police powers described in subsection (d) if:

5 (1) the officer successfully completes the pre-basic course
6 described in subsection (f); and

7 (2) the officer successfully completes any other training courses
8 established by the department of correction in conjunction with
9 the board.

10 SECTION 3. IC 5-2-6-3, AS AMENDED BY P.L.168-2014,
11 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
12 JULY 1, 2015]: Sec. 3. The institute is established to do the following:

13 (1) Evaluate state and local programs associated with:

14 (A) the prevention, detection, and solution of criminal
15 offenses;

16 (B) law enforcement; and

17 (C) the administration of criminal and juvenile justice.

18 (2) Improve and coordinate all aspects of law enforcement,
19 juvenile justice, and criminal justice in this state.

20 (3) Stimulate criminal and juvenile justice research.

21 (4) Develop new methods for the prevention and reduction of
22 crime.

23 (5) Prepare applications for funds under the Omnibus Act and the
24 Juvenile Justice Act.

25 (6) Administer victim and witness assistance funds.

26 (7) Administer the traffic safety functions assigned to the institute
27 under IC 9-27-2.

28 (8) Compile and analyze information and disseminate the
29 information to persons who make criminal justice decisions in this
30 state.

31 (9) Serve as the criminal justice statistical analysis center for this
32 state.

33 (10) Identify grants and other funds that can be used by the
34 department of correction to carry out its responsibilities
35 concerning sex or violent offender registration under IC 11-8-8.

36 (11) Administer the application and approval process for
37 designating an area of a consolidated or second class city as a
38 public safety improvement area under IC 36-8-19.5.

39 (12) Develop and maintain a meth watch program to inform
40 retailers and the public about illicit methamphetamine production,
41 distribution, and use in Indiana.

42 (13) Develop and manage the gang crime witness protection



1 program established by section 21 of this chapter.

2 (14) Identify grants and other funds that can be used to fund the
3 gang crime witness protection program.

4 (15) Administer any sexual offense services.

5 (16) Administer domestic violence programs.

6 (17) Administer assistance to victims of human sexual trafficking
7 offenses as provided in IC 35-42-3.5-4.

8 (18) Administer the domestic violence prevention and treatment
9 fund under IC 5-2-6.7.

10 (19) Administer the family violence and victim assistance fund
11 under IC 5-2-6.8.

12 **(20) In conjunction with the division of mental health and
13 addiction, establish the Indiana technical assistance center for
14 crisis intervention teams under IC 5-2-21.2.**

15 (21) Monitor and evaluate criminal code reform under
16 IC 5-2-6-24.

17 SECTION 4. IC 5-2-21.2 IS ADDED TO THE INDIANA CODE
18 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
19 JULY 1, 2015]:

20 **Chapter Indiana 21.2. Technical Assistance Center for Crisis
21 Intervention Teams**

22 **Sec. 1. As used in this chapter, "crisis intervention team trained
23 officer" means a law enforcement officer who has received training
24 by a local crisis intervention team regarding how to respond to an
25 individual in crisis.**

26 **Sec. 2. As used in this chapter, "crisis intervention team
27 training" means free training that crisis intervention teams
28 provide for law enforcement officers regarding:**

29 (1) signs and symptoms of mental health crisis;

30 (2) mental health treatment options in the local community;
31 and

32 (3) deescalation and crisis intervention techniques to facilitate
33 interaction and referrals to treatment.

34 **Sec. 3. As used in this chapter, "individual in crisis" means an
35 individual with:**

36 (1) mental illness;

37 (2) a substance addiction disorder; or

38 (3) both mental illness and a substance addiction disorder.

39 **Sec. 4. As used in this chapter, "institute" means the Indiana
40 criminal justice institute established by IC 5-2-6-3.**

41 **Sec. 5. As used in this chapter, "technical assistance center"
42 means a center established by the institute in conjunction with the**



1 division of mental health and addiction under IC 5-2-6-3(20) to
 2 support the development and sustainability of local crisis
 3 intervention teams.

4 **Sec. 6. The technical assistance center shall:**

5 **(1) identify grants and other funds that may be used to fund:**

6 **(A) local crisis intervention teams;**

7 **(B) law enforcement agencies; and**

8 **(C) evaluation of the effectiveness of crisis intervention
 9 team training;**

10 **(2) create and support a statewide crisis intervention team
 11 advisory committee that:**

12 **(A) includes representatives from:**

13 **(i) local crisis intervention teams;**

14 **(ii) state level stakeholders;**

15 **(iii) state agencies, including the division of mental
 16 health and addiction, the institute, the Indiana law
 17 enforcement academy and other agencies considered
 18 appropriate; and**

19 **(iv) advocacy organizations, including organizations
 20 representing people affected by mental illnesses and
 21 substance addiction disorders and other organizations
 22 considered appropriate;**

23 **(3) assist rural counties in creating crisis intervention teams
 24 and crisis intervention team training;**

25 **(4) provide established local crisis intervention teams with
 26 appropriate training, information, and technical assistance to:**

27 **(A) assist law enforcement agencies and law enforcement
 28 officers in providing a sense of dignity in crisis situations
 29 to an individual in crisis;**

30 **(B) identify underserved populations with mental illness,
 31 substance addiction disorders, or both, and link the
 32 populations to appropriate care;**

33 **(C) build partnerships and encourage formal agreements
 34 among local law enforcement, mental health providers,
 35 individuals and families affected by mental illness and
 36 substance addiction disorders, and other community
 37 stakeholders to improve system prevention and response

- (1) signs and symptoms of mental health crisis;
