## SENATE BILL No. 392

---

DIGEST OF SB 392 (Updated January 26, 2023 12:31 pm - DI 129)

**Citations Affected:** Noncode.

**Synopsis:** University housing for single mothers. Provides that the commission for higher education may administer a program to support JobSource, Inc., for the management of the Heartland/Anderson Scholar House. Provides that the purposes of the program include: (1) the expansion of program participant services; (2) residential and other support facility improvements and a one time debt reduction of \$250,000; (3) outreach to impoverished single mothers in minority communities; and (4) the provision of a scholarship gap fund for graduates staying in Indiana. Provides that administration costs incurred in the management of the Heartland/Anderson Scholar House may not exceed two percent 2% of the total program costs

**Effective:** July 1, 2023.

A BILL FOR AN ACT concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1           SECTION 1. [EFFECTIVE JULY 1, 2023] (a) **The commission for**  
2 **higher education (as defined in IC 21-7-13-11) may administer a**  
3 **program to support JobSource, Inc., for the management of the**  
4 **Heartland/Anderson Scholar House. If a program is established,**  
5 **the purposes of the program shall be:**  
6           (1) **the expansion of program participant services;**  
7           (2) **residential and other support facility improvements and a**  
8           **one (1) time debt reduction of two hundred fifty thousand**  
9           **dollars (\$250,000);**  
10          (3) **outreach to impoverished single mothers in minority**  
11          **communities; and**  
12          (4) **the provision of a scholarship gap fund for graduates**  
13          **staying in Indiana.**  
14          **Administration costs incurred in the management of the**  
15          **Heartland/Anderson Scholar House may not exceed two percent**  
16          **(2%) of the total program costs.**  
17          (b) **This SECTION expires June 30, 2025.**
