

SENATE BILL No. 408

DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-35-11.

Synopsis: Childhood obesity report. Requires the state department of health (state department) and the department of education to: (1) before August 1, 2019, provide specified information concerning childhood obesity to the management performance hub; and (2) before September 1, 2019, submit a written report summarizing the information to the public health, behavioral health, and human services interim study committee (interim study committee). Requires, before July 1, 2020, the state department to report outcomes of Indiana's Comprehensive Nutrition & Physical Activity Plan, 2010-2020 to the interim study committee.

Effective: Upon passage.

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 16-35-11 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]:

4 **Chapter 11. Child Obesity Information**
5 **Sec. 1. Before August 1, 2019, the state department and the**
6 **department of education shall provide the management**
7 **performance hub established by IC 4-3-26-8 with information and**
8 **statistics concerning childhood obesity. The information may**
9 **include the following:**

10 (1) **Statistics, by county and by school corporation, concerning**
11 **childhood obesity in Indiana, including data collected through**
12 **survey tools.**

13 (2) **Trends, by county and by school corporation, of child**
14 **obesity in Indiana for children who are at least ten (10) years**
15 **of age and less than eighteen (18) years of age since the**
16 **establishment of obesity initiatives in Indiana in 2004.**

17 **Sec. 2. Before September 1, 2019, the state department, in**



1 **consultation with the department of education, shall summarize the**
2 **information described in section 1 of this chapter and submit a**
3 **written report to the public health, behavioral health, and human**
4 **services interim study committee established by IC 2-5-1.3-4(14) in**
5 **an electronic format under IC 5-14-6.**

6 **Sec. 3. Before July 1, 2020, the state department shall report on**
7 **the outcomes of Indiana's Comprehensive Nutrition & Physical**
8 **Activity Plan, 2010-2020 to the public health, behavioral health,**
9 **and human services interim study committee established by**
10 **IC 2-5-1.3-4(14) in an electronic format under IC 5-14-6.**

11 **Sec. 4. This chapter expires December 31, 2020.**

12 **SECTION 2. An emergency is declared for this act.**
