SENATE BILL No. 408

DIGEST OF SB 408 (Updated January 29, 2014 3:24 pm - DI 104)

Citations Affected: IC 16-18; IC 16-19; noncode.

Synopsis: Neonatal abstinence syndrome. Defines "neonatal abstinence syndrome" (NAS). Requires a hospital to use appropriate hospital coding for diagnosing NAS and to report the NAS codes in accordance with hospital reporting requirements. Requires the state department of health (department) to provide a report before January 1, 2016, to the general assembly regarding the reported NAS data and specifies information to be included in the report. Authorizes the commission on improving the status of children in Indiana to: (1) study certain treatment services available to pregnant women who are addicted to illegal or prescription drugs; (2) study the educational and training services available to the public and certain professionals who might encounter an infant born with NAS during the course of their duties; and (3) make any recommendations for legislation as the committee considers appropriate.

Effective: July 1, 2014.

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

- 3 (c) Before January 1, 2016, the board shall, in consultation with
- 4 representatives of hospitals licensed under IC 16-21, provide a
- 5 report to the general assembly in an electronic format under
- 6 IC 5-14-6 regarding the NAS data reported under IC 16-21-6-6 and
- 7 IC 16-21-6-7. The report must include the following:
- 8 (1) Data and statistics regarding NAS determined by the state
- 9 department.
- 10 (2) Recommendations for appropriate education and training
- 11 to obstetric and gynecological physicians and treatment
- 12 providers of pregnant women.
- 13 (3) Recommendations for appropriate protocols for referrals
- 14 of pregnant women to addiction treatment providers.
- 15 SECTION 3. [EFFECTIVE JULY 1, 2014] (a) As used in this
- 16 SECTION, "commission" refers to the commission on improving
- 17 the status of children in Indiana established by IC 2-5-36-3.
- 18 (b) During the 2014 or 2015 legislative interim, the commission
- 19 may do the following:
- 20 (1) Study the prenatal medical treatment services that are
- 21 available to pregnant women addicted to illegal or
- 22 prescription drugs.
- 23 (2) Study the addiction treatment services that are available
- 24 to pregnant women addicted to illegal or prescription drugs.
- 25 (3) Study the educational and training services that are
- 26 available to:
- 27 (A) the public; and
- 28 (B) medical, social services, and governmental
- 29 professionals;
- 30 who might encounter an infant born with neonatal abstinence
- 31 syndrome (as defined by IC 16-19-3-4.5, as added by this act)
- 32 during the course of their duties.
- 33 (4) Make any recommendations for legislation as the
- 34 commission considers appropriate.
- 35 (c) This SECTION expires January 1, 2016.

Page 1, line 12, delete "Before November 1, 2014, the executive board shall adopt" and insert "**A hospital licensed under IC 16-21 shall:**

- (1) use appropriate International Classification of Diseases, Clinical Modification (ICD-CM) codes published by the National Center for Health Statistics for diagnosing NAS; and (2) file and report the ICD-CM codes referred to in subdivision (1) in accordance with IC 16-21-6-6 and IC 16-21-6-7."**

Page 1, delete lines 13 through 16.

Page 2, delete line 1.

Page 2, line 2, after "shall" insert "**, in consultation with representatives of hospitals licensed under IC 16-21,"**

Page 2, line 4, delete "first year of reporting under the emergency rules" and insert "**NAS data reported under IC 16-21-6-6 and IC 16-21-6-7."**

Page 2, line 5, delete "required by subsection (b)."

Page 2, line 7, delete "hospitals." and insert "**the state department."**

Page 2, delete lines 8 through 9.

Page 2, line 10, delete "(3)" and insert "**(2)"**."

Page 2, line 13, delete "(4)" and insert "**(3)"**."

Page 2, delete lines 15 through 42.

Page 3, delete lines 1 through 11.

Renumber all SECTIONS consecutively.
