ENGROSSED SENATE BILL No. 416

A BILL FOR AN ACT to amend the Indiana Code concerning Medicaid.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 12-15-5-7 IS ADDED TO THE INDIANA CODE
2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2019]: **Sec. 7. (a) Pregnancy services provided under this article
4 may include reimbursement for doula services.**
5 **(b) The office may apply for any state plan amendment or
6 waiver necessary to implement this section.**
7 **(c) The office may adopt rules under IC 4-22-2 to implement this
8 section.**
