DIGEST OF SB 434 (Updated February 13, 2018 8:37 am - DI 84)

Citations Affected: Noncode.

**Synopsis:** Study committee. Urges the legislative council to assign to the education interim study committee the task of studying: (1) the current regulatory framework and methods to streamline regulatory compliance; and (2) the use of innovative solutions and public-private partnerships in delivering educational services and sharing of best practices.

Effective: Upon passage.
