

SENATE BILL No. 459

DIGEST OF INTRODUCED BILL

Citations Affected: IC 4-3; IC 36-7-30.5.

Synopsis: Indiana defense task force. Repeals the military base planning council and reenacts it as the Indiana defense task force. Makes changes to the membership. Makes conforming changes.

Effective: July 1, 2019.

SENATE BILL No. 459

A BILL FOR AN ACT to amend the Indiana Code concerning military and veterans.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 4-3-21 IS REPEALED [EFFECTIVE JULY 1,
- 2 2019]. (Military Base Planning Council).
- 3 SECTION 2. IC 4-3-21.5 IS ADDED TO THE INDIANA CODE
- 4 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 5 JULY 1, 2019]:
- 6 **Chapter 21.5. Indiana Defense Task Force**
- 7 **Sec. 1. As used in this chapter, "military bases" refers to the**
- 8 **following:**
- 9 (1) **Military Assets.**
- 10 (2) **Military installations.**
- 11 (3) **Camp Atterbury.**
- 12 (4) **Crane Army Ammunition Activity.**
- 13 (5) **Fort Wayne International Airport.**
- 14 (6) **Glendora Lake Hydro-Acoustic Test Facility.**
- 15 (7) **Grissom Air Reserve Base.**
- 16 (8) **Hulman Field.**
- 17 (9) **Jefferson Proving Ground.**



1 **(10) Major General Emmett J. Bean Federal Center.**

2 **(11) Muscatatuck Urban Training Center.**

3 **(12) Naval Surface Warfare Center - Crane.**

4 **Sec. 2. As used in this chapter, "task force" refers to the Indiana**
 5 **defense task force established by section 3 of this chapter.**

6 **Sec. 3. The Indiana defense task force is established.**

7 **Sec. 4. The task force consists of the following members:**

8 **(1) The lieutenant governor or the lieutenant governor's**
 9 **designee.**

10 **(2) The director of the Indiana office of defense development.**

11 **(3) The following members chosen by the military assets in**
 12 **their geographic areas:**

13 **(A) One (1) member representing the Southern Indiana**
 14 **Defense Network.**

15 **(B) One (1) member representing Radius Indiana.**

16 **(C) One (1) member representing greater Fort Wayne**
 17 **Indiana.**

18 **(D) One (1) member representing Defense Finance and**
 19 **Accounting Service, Lawrence, Indiana.**

20 **(E) One (1) member representing Grissom Regional**
 21 **Defense Alliance.**

22 **(F) One (1) member representing West Central Indiana**
 23 **Defense Network.**

24 **(G) One (1) member representing the Michigan City Coast**
 25 **Guard Station.**

26 **(H) One (1) member representing the Indiana Aerospace**
 27 **and Defense Council.**

28 **(I) One (1) member representing procurement and**
 29 **technical assistance.**

30 **(J) One (1) member representing the Indiana Innovation**
 31 **Institute.**

32 **(K) One (1) member representing the National Defense**
 33 **Industrial Association, Indiana Chapter, Tier 2/Tier 3**
 34 **Suppliers.**

35 **Sec. 5. (a) Each member of the task force who is not a state**
 36 **employee is not entitled to the minimum salary per diem provided**
 37 **by IC 4-10-11-2.1(b). The member is, however, entitled to**
 38 **reimbursement for traveling expenses as provided under**
 39 **IC 4-13-1-4 and other expenses actually incurred in connection**
 40 **with the member's duties as provided in the state policies and**
 41 **procedures established by the Indiana department of**
 42 **administration and approved by the budget agency.**



1 (b) Each member of the task force who is a state employee but
 2 who is not a member of the general assembly is entitled to
 3 reimbursement for traveling expenses as provided under
 4 IC 4-13-1-4 and other expenses actually incurred in connection
 5 with the member's duties as provided in the state policies and
 6 procedures established by the Indiana department of
 7 administration and approved by the budget agency.

8 (c) Each member of the task force who is a member of the
 9 general assembly is entitled to receive the same per diem, mileage,
 10 and travel allowances paid to legislative members of interim study
 11 committees established by the legislative council. Per diem,
 12 mileage, and travel allowances paid under this subsection shall be
 13 paid from appropriations made to the legislative council or the
 14 legislative services agency.

15 Sec. 6. The governor shall designate a member of the task force
 16 to serve as chairperson of the task force.

17 Sec. 7. The task force shall meet at the call of the chairperson.

18 Sec. 8. The governor shall provide staff assistance as the task
 19 force may require.

20 Sec. 9. A member of the task force who is a member of the
 21 general assembly is a nonvoting member.

22 Sec. 10. The affirmative votes of a majority of the voting
 23 members of the task force are required for the task force to take
 24 action on any measure, including reports required under section 12
 25 of this chapter.

26 Sec. 11. The task force shall do the following:

27 (1) Identify the public infrastructure and other community
 28 support necessary:

29 (A) to improve mission efficiencies; and

30 (B) for the development and expansion;

31 of military bases in Indiana.

32 (2) Identify existing and potential impacts of encroachment on
 33 military bases in Indiana.

34 (3) Identify potential state and local government actions that
 35 can:

36 (A) minimize the impacts of encroachment on; and

37 (B) enhance the long term potential of;

38 military bases in Indiana.

39 (4) Identify opportunities for collaboration among:

40 (A) the state, including the military department of the
 41 state;

42 (B) political subdivisions;



- 1 (C) military contractors; and
 2 (D) academic institutions;
 3 to maintain and expand the missions of Indiana's military
 4 bases.
 5 (5) Study how governmental entities outside Indiana have
 6 addressed issues regarding encroachment and partnership
 7 formation described in this section.
 8 (6) With respect to a multicounty federal military base under
 9 IC 36-7-30.5:
 10 (A) vote to require the establishment of the development
 11 authority under IC 36-7-30.5, if necessary; and
 12 (B) advise and submit recommendations to a development
 13 authority board appointed under IC 36-7-30.5.
 14 (7) Strengthen state support for military families and veterans
 15 in the areas of education, health care, employment, and family
 16 programs. The areas listed in this subdivision do not comprise
 17 an exhaustive list of the areas for which the task force may
 18 strengthen state support for military families and veterans.
- 19 **Sec. 12. The task force shall submit a report to the:**
 20 (1) governor; and
 21 (2) legislative services agency;
 22 not later than July 1 of each year. The report submitted to the
 23 legislative services agency must be in an electronic format under
 24 IC 5-14-6.
- 25 SECTION 3. IC 36-7-30.5-3 IS REPEALED [EFFECTIVE JULY
 26 1, 2019]. **Sec. 3. As used in this chapter, "council" refers to the military**
 27 **base planning council established under IC 4-3-21-3.**
- 28 SECTION 4. IC 36-7-30.5-6.5 IS ADDED TO THE INDIANA
 29 CODE AS A NEW SECTION TO READ AS FOLLOWS
 30 [EFFECTIVE JULY 1, 2019]: **Sec. 6.5. As used in this chapter, "task**
 31 **force" refers to the Indiana defense task force established by**
 32 **IC 4-3-21.5-3.**
- 33 SECTION 5. IC 36-7-30.5-8, AS ADDED BY P.L.203-2005,
 34 SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 35 JULY 1, 2019]: **Sec. 8. (a) If the ~~council~~; task force, by the affirmative**
 36 **votes of a majority of the voting members of the ~~council~~; task force,**
 37 **votes to require that a development authority should be established**
 38 **under this chapter, the development authority shall be established.**
- 39 (b) A unit may not create a reuse authority under IC 36-7-30 for all
 40 or part of a military base that is:
 41 (1) governed by this chapter; and
 42 (2) located within the boundaries of the unit.



1 SECTION 6. IC 36-7-30.5-14, AS ADDED BY P.L.203-2005,
2 SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2019]: Sec. 14. The development authority shall do the
4 following:

5 (1) Investigate, study, and survey the area surrounding and the
6 real property and structures that are part of the military base.

7 (2) Investigate, study, and determine the means by which military
8 base property may be developed or reused by private enterprise to
9 promote economic development within counties represented on
10 the development authority or by state and local government to
11 otherwise benefit the welfare of the citizens of the counties
12 represented on the development authority.

13 (3) Promote the development of military base property in the
14 manner that best serves the interests of the state and its
15 inhabitants.

16 (4) Cooperate with the departments and agencies of units and of
17 other governmental entities, including the state and the federal
18 government, in the manner that best serves the purposes of this
19 chapter.

20 (5) Make findings and reports on their activities under this
21 section, and keep the reports available for inspection by the
22 public.

23 (6) Select and acquire military base property to be developed or
24 reused by private enterprise or state or local government under
25 this chapter.

26 (7) Transfer acquired military base property and other real and
27 personal property to private enterprise or state or local
28 government in the manner that best serves the social and
29 economic interests of the state and the state's inhabitants.

30 (8) Consider recommendations made by the ~~council~~ **task force**
31 concerning the operations of the development authority.
