SENATE BILL No. 469

DIGEST OF SB 469 (Updated February 5, 2015 2:34 pm - DI 101)

Citations Affected: Noncode.

Synopsis: Rural broadband. Urges the legislative council (council) to assign to the interim study committee on energy, utilities, and telecommunications (committee) the topic of the provision of affordable broadband services in unserved areas in Indiana. Provides that if the topic is assigned to the committee, the committee shall: (1) consider specific strategies to encourage the provision of affordable broadband services in unserved areas in Indiana; and (2) issue a final report, including any recommendations for legislation, to the council not later than November 1, 2015.

Effective: July 1, 2015.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 2014 Regular Session and 2014 Second Regular Technical Session of the General Assembly.

A BILL FOR AN ACT concerning utilities.

Be it enacted by the General Assembly of the State of Indiana:

10 (d) **If the topic described in subsection (c) is assigned to the**
11 **committee, the committee shall consider, as part of its study,**
12 **specific strategies to encourage the provision of affordable**
13 **broadband services in unserved areas in Indiana.**
14 (e) **If the topic described in subsection (c) is assigned to the**
15 **committee, the committee shall issue a final report to the legislative**
16 **council containing the committee's findings and recommendations,**
17 **including any recommended legislation concerning the topic**
