

SENATE BILL No. 471

DIGEST OF INTRODUCED BILL

Citations Affected: IC 3-11-19.

Synopsis: Straight ticket voting pilot program. Establishes a straight ticket voting pilot program for the 2016 and 2018 general elections. Requires the secretary of state to designate three counties as straight ticket voting pilot counties based on county population. Requires a county designated as a straight ticket voting pilot county to remove from the ballot the option for a voter to vote for all candidates of a political party or an independent ticket at one time or with one mark, except for candidates for presidential electors. Authorizes the secretary of state to adopt a process to allow counties to apply to be designated a straight ticket voting pilot county. Permits the secretary of state to revoke a county's designation as a straight ticket voting pilot county under certain circumstances.

Effective: July 1, 2015.

SENATE BILL No. 471

A BILL FOR AN ACT to amend the Indiana Code concerning elections.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 3-11-19 IS ADDED TO THE INDIANA CODE AS
2 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2015]:
4 **Chapter 19. Straight Ticket Voting Pilot Program**
5 **Sec. 1. This chapter applies to a county designated as a straight**
6 **ticket voting pilot county under this chapter.**
7 **Sec. 2. (a) Not later than January 1, 2016, the secretary of state**
8 **shall designate three (3) counties as straight ticket voting pilot**
9 **counties under this chapter.**
10 **(b) The three (3) counties to be designated under this section are**
11 **as follows:**
12 **(1) One (1) county having a consolidated city.**
13 **(2) One (1) county having a population of more than one**
14 **hundred thirty-five thousand (135,000), but less than one**
15 **hundred seventy-five thousand (175,000).**
16 **(3) One (1) county having a population of less than thirty**



1 thousand (30,000).

2 (c) The designation of a county as a straight ticket voting pilot
3 county takes effect immediately unless otherwise specified by the
4 secretary of state.

5 Sec. 3. (a) Notwithstanding any other law, a county designated
6 as a straight ticket voting pilot county shall remove from the ballot
7 the option for a voter to vote for all candidates of a political party
8 or an independent ticket at one (1) time or with one (1) mark,
9 except for candidates for presidential electors.

10 (b) Straight ticket voting pilot counties shall conduct the pilot
11 project during the 2016 and 2018 general elections.

12 Sec. 4. The secretary of state may adopt a process to allow
13 counties to apply to be designated a straight ticket voting pilot
14 county.

15 Sec. 5. Except as otherwise provided by this chapter, a straight
16 ticket voting pilot county shall administer an election during which
17 the pilot project is conducted in accordance with federal law and
18 this title.

19 Sec. 6. (a) The designation of a county as a straight ticket voting
20 pilot county may be revoked by the secretary of state:

21 (1) following the filing of a request for revocation approved by
22 the unanimous vote of the entire membership of the county
23 election board (or the board of elections and registration
24 established under IC 3-6-5.4) and signed by all the members
25 of the board; or

26 (2) upon a determination by the secretary of state that the
27 administration of the straight ticket voting pilot project
28 within the county does not comply with federal or state law.

29 (b) If the designation of a county as a straight ticket voting pilot
30 county is revoked in accordance with subsection (a), the secretary
31 of state shall designate a replacement county as a straight ticket
32 voting pilot county.

33 Sec. 7. The secretary of state may adopt guidelines to administer
34 the straight ticket voting pilot program under this chapter.

35 Sec. 8. This chapter expires December 31, 2018.
