## ENGROSSED SENATE BILL No. 480

---

DIGEST OF SB 480 (Updated April 4, 2019 12:33 pm - DI 104)

**Citations Affected:** IC 12-7; IC 12-15.

**Synopsis:** Medicaid nonemergency medical transport. Sets forth requirements for brokers of nonemergency medical transportation under the Medicaid fee-for-service program. Establishes the nonemergency medical transportation commission (commission) and sets forth duties of the commission. Requires the office of the secretary of family and social services to prepare before October 1, 2019, a report concerning nonemergency medical transportation Medicaid claims and submit the report to the commission.

**Effective:** July 1, 2019.

13 **Sec. 2. As used in this chapter, "commission" refers to the  
 14 nonemergency medical transportation commission established by  
 15 section 7 of this chapter.**

16 **Sec. 3. As used in this chapter, "nonemergency medical  
 17 transportation" means medically necessary transportation to  
 18 Medicaid covered services for an eligible Medicaid recipient who:**

- 19 (1) participates in the Medicaid fee-for-service program; and  
 20 (2) does not have available transportation to:  
 21 (A) a Medicaid reimbursable service; or  
 22 (B) a pharmacy to obtain Medicaid reimbursable  
 23 pharmacy services.

24 **Sec. 4. (a) A broker must do the following:**

25 (1) Submit monthly reports to the office of the secretary for  
 26 the office of the secretary to post on the office of the  
 27 secretary's Internet web site of the following:

28 (A) A list and map by county of the number of vehicles, by  
 29 vehicle type, that are contracted, credentialed, and  
 30 available to provide nonemergency medical transportation  
 31 in that county.

32 (B) Based upon a comparison of trip-leg identification  
 33 numbers issued by the broker to the corresponding claim  
 34 submitted with that trip-leg identification number, the  
 35 number of instances in which a requested nonemergency  
 36 medical transportation for an eligible Medicaid recipient  
 37 was not provided, including whether:

- 38 (i) the instance related to picking up the recipient to go  
 39 to an appointment;

- 10 (D) A summary of the complaints received by the broker,
- 11 whether or not the complaints have been substantiated.
- 12 Information under this clause must include the total
- 13 number of complaints and whether the complaint related
- 14 to:
- 15 (i) a scheduled ride to go to an appointment;
- 16 (ii) a scheduled ride from an appointment; and
- 17 (iii) a recipient who resided in the community, a health
- 18 facility, an intermediate care facility for individuals with
- 19 intellectual disabilities, a hospital, or another location.
- 20 (2) Submit monthly to the office of the secretary for the office
- 21 of the secretary to post on the office of the secretary's Internet
- 22 web site a report comparing:
- 23 (A) the number of eligible Medicaid recipients; to
- 24 (B) the number of contracted and credentialed
- 25 transportation vehicles, by type and by county, that are
- 26 available to provide nonemergency medical transportation
- 27 in a county;
- 28 and including the calculation of the ratio of eligible Medicaid
- 29 recipients to vehicle type.
- 30 (3) Submit a monthly report to the office of the secretary that
- 31 includes the following information for the previous month:
- 32 (A) The number of ride requests received and scheduled
- 33 trip-leg identification numbers issued.
- 34 (B) Call center statistics.
- 35 (C) Information on claims payments, including claim
- 36 denial reason codes.
- 37 (D) Program integrity referrals.
- 38 (E) Information concerning grievances and appeals,
- 39 including the status of any grievance or appeal that is
- 40 either open or closed in the month of the report.
- 41 (b) If the broker has not assigned a transportation provider to
- 42 a request for nonemergency medical transportation within



1 forty-eight (48) hours of the time in which the transportation is to  
 2 be provided, the broker shall do the following:

3 (1) Take steps to notify the:

4 (A) Medicaid recipient for which the request was made;  
 5 and

6 (B) health facility, if the Medicaid recipient resides in a  
 7 health facility;

8 that a transportation provider has not yet been assigned.

9 (2) Continue to make every effort in securing transportation  
 10 for the Medicaid recipient and immediately notify the  
 11 recipient described in subdivision (1)(A) and, if applicable, the  
 12 health facility described in subdivision (1)(B), when  
 13 transportation has been assigned.

14 (3) Document whether the notice required under subdivision  
 15 (1) was communicated to the Medicaid recipient or a person  
 16 on behalf of the Medicaid recipient, and the method of  
 17 communication.

18 **Sec. 5. (a)** A broker shall establish, implement, and maintain the  
 19 following:

20 (1) One (1) toll free telephone number clearly identified for  
 21 the handling of complaints concerning the nonemergency  
 22 medical transportation services.

23 (2) A link on the home page of the broker's Internet web site  
 24 titled "File a Complaint Here" that is accessible by the public  
 25 and that allows for the submission of a complaint concerning  
 26 the nonemergency medical transportation services.

27 (3) Instructions on the broker's Internet web site on how to  
 28 file a complaint concerning nonemergency medical  
 29 transportation services.

30 (4) A process to notify a person who files a complaint about:

31 (A) the steps the broker will take to investigate the  
 32 complaint; and

33 (B) the results of the investigation.

34 (b) Except for disclosure to the office of the secretary, the  
 35 broker shall keep confidential the identity of any individual who  
 36 submits a complaint with the broker concerning nonemergency  
 37 medical transportation services.

38 (c) If a complaint concerning nonemergency medical  
 39 transportation services made to the broker is substantiated, the  
 40 broker shall develop a remediation plan concerning the complaint  
 41 and submit the remediation plan to the office of the secretary for  
 42 the office of the secretary to post the remediation plan on the office

2 **Sec. 6. (a) Before October 1, 2019, the office of the secretary**  
 3 **shall prepare a report containing the number of Medicaid**  
 4 **fee-for-service nonemergency medical transportation claims paid**  
 5 **by:**

- 6 (1) vehicle type;  
 7 (2) Medicaid recipient category; and  
 8 (3) whether the recipient for which the claim was paid resided  
 9 in:  
 10 (A) the community;  
 11 (B) a health facility;  
 12 (C) an intermediate care facility for individuals with  
 13 intellectual disabilities;  
 14 (D) a hospital; or  
 15 (E) another location.

16 (b) Beginning June 1, 2016, through May 31, 2019, the claims  
 17 data reported in subsection (a) must be organized by month.

18 (c) The office of the secretary shall submit the report prepared  
 19 under subsection (a) to the commission.

20 **Sec. 7. (a) The nonemergency medical transportation**  
 21 **commission is established for the purpose of overseeing the**  
 22 **provision of nonemergency medical transportation services to**  
 23 **ensure that Medicaid fee-for-service recipients are receiving**  
 24 **satisfactory service and to ensure that brokers pay the claims of**  
 25 **transportation providers in a timely manner.**

26 (b) The commission consists of the following members:

- 27 (1) Two (2) members of the senate, who may not be members  
 28 of the same political party, appointed by the president pro  
 29 tempore of the senate with the advice of the minority leader  
 30 of the senate.  
 31 (2) Two (2) members of the house of representatives, who may  
 32 not be members of the same political party, appointed by the  
 33 speaker of the house of representatives with the advice of the  
 34 minority leader of the house of representatives.  
 35 (3) One (1) representative of the office of the secretary.  
 36 (4) One (1) individual representing a broker.  
 37 (5) One (1) individual representing a transportation provider  
 38 that has contracted with a broker.  
 39 (6) One (1) individual representing the Indiana Hospital  
 40 Association.  
 41 (7) One (1) individual representing the Indiana Health Care  
 42 Association.



- 1           **(8) One (1) individual representing the Indiana Association of**  
 2           **Rehabilitation Facilities.**  
 3           **(9) One (1) individual representing the Arc of Indiana.**  
 4           **(10) One (1) physician licensed under IC 25-22.5.**  
 5           **(11) One (1) individual representing dialysis providers.**  
 6           **(12) One (1) Medicaid fee-for-service recipient.**  
 7           **(13) One (1) individual representing the Indiana Association**  
 8           **of Area Agencies on Aging.**  
 9           **(14) One (1) individual representing the Indiana Emergency**  
 10           **Medical Services Association.**  
 11           **(c) The members of the commission described in subsection**  
 12           **(b)(1) and (b)(2) shall serve:**  
 13               **(1) as nonvoting advisory members; and**  
 14               **(2) for a four (4) year term.**  
 15           **(d) The members of the commission described in subsection**  
 16           **(b)(3) through (b)(14) shall be appointed by the governor for terms**  
 17           **of four (4) years. The term of a member of the commission expires**  
 18           **July 1. However, a member may continue to serve until a successor**  
 19           **is appointed. In case of a vacancy, the governor shall appoint an**  
 20           **individual to serve for the remainder of the unexpired term. The**  
 21           **governor shall designate one (1) member described in this**  
 22           **subsection as chairperson of the commission.**  
 23           **(e) The initial appointments beginning July 1, 2019, must be:**  
 24               **(1) made by the governor not later than October 1, 2019; and**  
 25               **(2) notwithstanding subsection (d), staggered as follows:**  
 26                   **(A) Two (2) years for the members appointed under**  
 27                   **subsection (b)(4), (b)(6), (b)(8), (b)(10), (b)(12), and (b)(14).**  
 28                   **(B) Three (3) years for the members appointed under**  
 29                   **subsection (b)(5), (b)(7), (b)(9), (b)(11), and (b)(13).**  
 30           **This subsection expires July 1, 2024.**  
 31           **(f) The office shall provide staff support and technical assistance**  
 32           **to the commission, including the collection of and dissemination of**  
 33           **data and reports required by this chapter, in order for the**  
 34           **commission to carry out its duties under this chapter.**  
 35           **Sec. 8. (a) Each member of the commission who is not a state**  
 36           **employee is entitled to the minimum salary per diem provided by**  
 37           **IC 4-10-11-2.1(b). Such a member is also entitled to reimbursement**  
 38           **for traveling expenses and other expenses actually incurred in**  
 39           **connection with the member's duties, as provided in the state travel**  
 40           **policies and procedures established by the Indiana department of**  
 41           **administration and approved by the budget agency.**  
 42           **(b) Each member of the commission who is a state employee but**





1 who is not a member of the general assembly is entitled to  
2 reimbursement for traveling expenses and other expenses actually  
3 incurred in connection with the member's duties, as provided in the  
4 state travel policies and procedures established by the Indiana  
5 department of administration and approved by the budget agency.

6 (c) Each member of the commission who is a member of the  
7 general assembly is entitled to receive the same per diem, mileage,  
8 and travel allowances paid to legislative members of interim study  
9 committees established by the legislative council. Per diem,  
10 mileage, and travel allowances paid under this subsection shall be  
11 paid from appropriations made to the legislative council or the  
12 legislative services agency.

13 **Sec. 9. The commission shall meet at least two (2) times per year  
14 at a public meeting to do the following:**

15 (1) Review a report submitted under this chapter.

16 (2) Provide feedback and make recommendations to the office  
17 of the secretary concerning the provision of nonemergency  
18 medical transportation services.

19 (3) Approve any monies to be awarded to a broker as part of  
20 a withhold provision outlined in the contract between the  
21 office of the secretary and the broker.

- (B) **Call center statistics.**
- (C) **Information on claims payments.**
- (D) **Program integrity referrals.**
- (E) **Information concerning grievances and appeals, including the status of any grievance or appeal that is either open or closed in the month of the report."**
