Citations Affected: Noncode.

Synopsis: Veterans cemetery funding. Makes an appropriation from the state general fund to the Indiana department of veterans' affairs to be used for the establishment, operation, and maintenance of a veterans cemetery at Oak Hill Cemetery in Evansville.

Effective: July 1, 2019.

SENATE BILL No. 492

A BILL FOR AN ACT concerning military and veterans and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE JULY 1, 2019] (a) **There is**
2 **appropriated from the state general fund to the Indiana**
3 **department of veterans' affairs for the period beginning July 1,**
4 **2019, and ending June 30, 2021, six hundred thousand dollars**
5 **(\$600,000) for the purpose of establishing, operating, and**
6 **maintaining a veterans cemetery at Oak Hill Cemetery in**
7 **Evansville.**
8 (b) **This SECTION expires June 30, 2021.**
