**Synopsis:** Study of ethnic history. Requires the study of ethnic and racial groups to be included as part of each school corporation's high school United States history course.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 2014 Regular Session and 2014 Second Regular Technical Session of the General Assembly.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 20-30-5-7, AS AMENDED BY P.L.86-2007,  
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2015]: Sec. 7. Each school corporation shall include in the  
4 school corporation's curriculum the following studies:  
5 (1) Language arts, including:  
6 (A) English;  
7 (B) grammar;  
8 (C) composition;  
9 (D) speech; and  
10 (E) second languages.  
11 (2) Mathematics.  
12 (3) Social studies and citizenship, including the:  
13 (A) constitutions;  
14 (B) governmental systems; and  
15 (C) histories;  
16 of Indiana and the United States, including a study of the

- 1 Holocaust **and the study of ethnic and racial groups**, in each
- 2 high school United States history course.
- 3 (4) Sciences.
- 4 (5) Fine arts, including music and art.
- 5 (6) Health education, physical fitness, safety, and the effects of
- 6 alcohol, tobacco, drugs, and other substances on the human body.
- 7 (7) Additional studies selected by each governing body, subject
- 8 to revision by the state board.
