



ENGROSSED SENATE BILL No. 532

DIGEST OF SB 532 (Updated April 8, 2019 11:13 am - DI 116)

Citations Affected: IC 20-28.

Synopsis: Teacher licensing examinations. Provides that the department of education (department) shall convene a panel of stakeholders designated by the department, which must consist of teachers and representatives from postsecondary education, to adopt licensure examinations to replace the current teacher licensing examination.

Effective: Upon passage; July 1, 2019.

ENGROSSED SENATE BILL No. 532

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 20-28-5-12, AS AMENDED BY P.L.106-2016,

2	SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	JULY 1, 2019]: Sec. 12. (a) Subsection (b) does not apply to an
4	individual who:
5	(1) held an Indiana limited, reciprocal, or standard teaching
6	license on June 30, 1985; or
7	(2) is granted a license under section 18 of this chapter.
8	(b) The department may not grant an initial practitioner license to
9	an individual unless the individual has demonstrated proficiency in the
10	following areas on a written examination or through other procedures
11	prescribed by the department:
12	(1) Basic reading, writing, and mathematics.
13	(2) Pedagogy.
14	(3) Knowledge of the areas in which the individual is required to

2	(A) phonemic awareness;
3	(B) phonics instruction;

7	(c) An individual's license examination score may not be disclosed
8	by the department without the individual's consent unless specifically
9	required by state or federal statute or court order.
10	(d) Subject to section 22 of this chapter, the state board shall
11	adopt rules under IC 4-22-2 to do the following:
12	(1) Adopt, validate, and implement the examination or other
13	procedures required by subsection (b).
14	(2) Establish examination scores indicating proficiency.
15	(3) Otherwise carry out the purposes of this section.
16	(e) Subject to section 18 of this chapter, the state board shall adopt
17	rules under IC 4-22-2 establishing the conditions under which the

19	a valid teacher's license issued by another state.

Page 2, delete lines 33 through 39, begin a new paragraph and insert:

- "(c) The state board shall adopt teacher licensing examinations that are already in existence and administered nationally.
- (d) The department shall, not later than September 1, 2021, implement the teacher licensing examinations adopted under this section."

Replace the effective date in SECTION 2 with "[EFFECTIVE UPON PASSAGE]".

Page 2, delete lines 30 through 39, begin a new paragraph and insert:

- "(b) The department shall convene a panel of stakeholders designated by the department, which must consist of teachers and representatives from postsecondary education, to adopt teacher licensing examinations to replace the teacher licensing examinations administered on July 1, 2019. The panel shall consider whether to use a national examination or an examination customized for Indiana's teaching needs.
- (c) Not later than July 1, 2019, the panel shall adopt teacher licensing examinations to replace the teacher licensing examination



administered on July 1, 2019.

(d) Not later than September 1, 2021, the department shall implement the teacher licensing examinations adopted by the panel under this section. The state board may adopt rules under IC 4-22-2 necessary to implement this section.

SECTION 3. An emergency is declared for this act.".
