ENGROSSED SENATE BILL No. 533

DIGEST OF SB 533 (Updated March 21, 2019 10:15 am - DI 133)

Citations Affected: IC 15-17.

Synopsis: Importation of domestic animals from abroad. Provides that any person who transfers a domestic dog or cat from a foreign country into Indiana shall provide the recipient of the domestic dog or cat with a copy of the domestic dog's or cat's certificate of veterinary inspection or official health certificate. Provides that a person who receives a domestic dog or cat that is imported from a foreign country into Indiana shall submit to the state board of animal health a copy of the domestic dog's or cat's certificate of veterinary inspection or official health certificate not more than 30 days after receiving the domestic dog or cat. Permits a person to provide or submit an electronic copy of a domestic dog's or cat's certificate of veterinary inspection or official health certificate.

Effective: July 1, 2019.

ENGROSSED SENATE BILL No. 533

A BILL FOR AN ACT to amend the Indiana Code concerning agriculture and animals.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 15-17-21 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE

7 **domestic dog or cat under subsection (b) with a copy of the**
8 **domestic dog's or cat's:**
9 (1) **certificate of veterinary inspection; or**
10 (2) **official health certificate.**
11 (b) **A person who receives a domestic dog or cat that is imported**
12 **from a foreign country into Indiana shall submit to the board a**
13 **copy of the domestic dog's or cat's:**
14 (1) **certificate of veterinary inspection; or**
15 (2) **official health certificate;**
16 **received under subsection (a) not more than thirty (30) days after**
17 **receiving the domestic dog or cat.**
