### DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 20-18-2; IC 20-19; IC 20-20; IC 20-24; IC 20-24.2-4; IC 20-25-3-6; IC 20-25.7; IC 20-26; IC 20-28; IC 20-29; IC 20-30; IC 20-31; IC 20-32; IC 20-33-2-13; IC 20-35-8-1; IC 20-36-5-1; IC 20-43-10-3; IC 20-51-1-4.7; IC 20-51-1-6.

**Synopsis:** Education. Replaces ISTEP program testing with BEST testing program for school years beginning after June 30, 2016, and eliminates end of Core 40 course assessments after the 2014-2015 school year. Provides for innovation network school programs in school corporations other than the Indianapolis Public Schools. Extends the school performance grant program through the 2016-2017 school year, and makes changes in the calculation and use of the grant for stipends to teachers. Permits teachers to receive a supplemental amount for completion of certain master's degrees. Requires the department of education to establish a program to permit an individual with a major in science, technology, engineering, or mathematics and a minor in education to obtain a teaching license. Requires school employers to bring collective bargaining agreements into conformity with law, provides for oversight by the education employment relations board to bring these agreements into compliance, permits certificated employees to be paid based on adopted salary ranges rather than salary schedules, and makes other changes in collective bargaining.

**Effective:** Upon passage; January 1, 2015 (retroactive); June 30, 2015; July 1, 2015; July 1, 2016.

## SENATE BILL No. 566

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 20-18-2-2.3 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE  
3 UPON PASSAGE]: **Sec. 2.3. "BEST program" refers to the**  
4 **benchmarking excellence student testing program developed and**  
5 **administered under IC 20-32-5.1.**

6 SECTION 2. IC 20-18-2-6, AS ADDED BY P.L.1-2005, SECTION  
7 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON  
8 PASSAGE]: Sec. 6. "Graduation examination" means:

9 **(1) for school years ending before July 1, 2016, the test**  
10 **designated by the board under the ISTEP program; and**

11 **(2) for school years beginning after June 30, 2016, the test**  
12 **designed by the board under the BEST program.**

13 SECTION 3. IC 20-18-2-10, AS ADDED BY P.L.1-2005,  
14 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
15 UPON PASSAGE]: Sec. 10. "ISTEP program" refers to the Indiana  
16 statewide testing for educational progress program developed and



1 administered under IC 20-32-5 (**repealed effective July 1, 2016**).

2 SECTION 4. IC 20-18-2-22, AS AMENDED BY P.L.43-2014,  
3 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
4 UPON PASSAGE]: Sec. 22. (a) "Teacher" means a professional person  
5 whose position in a school corporation requires certain educational  
6 preparation and licensing and whose primary responsibility is the  
7 instruction of students.

8 (b) For purposes of IC 20-28, the term includes the following:

- 9 (1) A superintendent who holds a license under IC 20-28-5.  
10 (2) A principal.  
11 (3) A teacher.  
12 (4) A librarian.  
13 (5) A school counselor.

14 **(c) For purposes of IC 20-43-10-3, the term means a professional**  
15 **person or a paraprofessional person whose position with a school**  
16 **corporation or a charter school requires a license (as defined in**  
17 **IC 20-28-1-7) and whose primary responsibility is the instruction**  
18 **of students. The term includes teachers in a school corporation's or**  
19 **charter school's special education program or career and technical**  
20 **education program, including programs managed under**  
21 **IC 20-35-5, IC 20-26-10, IC 20-37, or IC 36-1-7.**

22 SECTION 5. IC 20-19-2-8, AS AMENDED BY P.L.286-2013,  
23 SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
24 UPON PASSAGE]: Sec. 8. (a) In addition to any other powers and  
25 duties prescribed by law, the state board shall adopt rules under  
26 IC 4-22-2 concerning, but not limited to, the following matters:

- 27 (1) The designation and employment of the employees and  
28 consultants necessary for the department. The state board shall fix  
29 the compensation of employees of the department, subject to the  
30 approval of the budget committee and the governor under  
31 IC 4-12-2.  
32 (2) The establishment and maintenance of standards and  
33 guidelines for media centers, libraries, instructional materials  
34 centers, or any other area or system of areas in a school where a  
35 full range of information sources, associated equipment, and  
36 services from professional media staff are accessible to the school  
37 community. With regard to library automation systems, the state  
38 board may only adopt rules that meet the standards established by  
39 the state library board for library automation systems under  
40 IC 4-23-7.1-11(b).  
41 (3) The establishment and maintenance of standards for student  
42 personnel and guidance services.



1 (4) The inspection of all public schools in Indiana to determine  
 2 the condition of the schools. The state board shall establish  
 3 standards governing the accreditation of public schools.

4 Observance of:

5 (A) IC 20-31-4;

6 (B) IC 20-28-5-2;

7 (C) IC 20-28-6-3 through IC 20-28-6-7;

8 (D) IC 20-28-11.5; and

9 (E) IC 20-31-3, **for school years ending before July 1, 2016,**

10 IC 20-32-4, IC 20-32-5 (**repealed effective July 1, 2016**), **for**

11 **school years beginning after June 30, 2016, IC 20-32-5.1,**

12 and IC 20-32-8;

13 is a prerequisite to the accreditation of a school. Local public  
 14 school officials shall make the reports required of them and  
 15 otherwise cooperate with the state board regarding required  
 16 inspections. Nonpublic schools may also request the inspection  
 17 for classification purposes. Compliance with the building and site  
 18 guidelines adopted by the state board is not a prerequisite of  
 19 accreditation.

20 (5) The distribution of funds and revenues appropriated for the  
 21 support of schools in the state.

22 (6) The state board may not establish an accreditation system for  
 23 nonpublic schools that is less stringent than the accreditation  
 24 system for public schools.

25 (7) A separate system for recognizing nonpublic schools under  
 26 IC 20-19-2-10. Recognition of nonpublic schools under this  
 27 subdivision constitutes the system of regulatory standards that  
 28 apply to nonpublic schools that seek to qualify for the system of  
 29 recognition.

30 (8) The establishment and enforcement of standards and  
 31 guidelines concerning the safety of students participating in  
 32 cheerleading activities.

33 (9) Subject to IC 20-28-2, the preparation and licensing of  
 34 teachers.

35 (b) Before final adoption of any rule, the state board shall make a  
 36 finding on the estimated fiscal impact that the rule will have on school  
 37 corporations.

38 SECTION 6. IC 20-19-2-14, AS AMENDED BY P.L.286-2013,  
 39 SECTION 12, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 40 UPON PASSAGE]: Sec. 14. The state board shall do the following:

41 (1) Establish the educational goals of the state, developing  
 42 standards and objectives for local school corporations.



- 1 (2) Assess the attainment of the established goals.  
 2 (3) Assure compliance with established standards and objectives.  
 3 (4) Coordinate with the commission for higher education  
 4 (IC 21-18-1) and the department of workforce development  
 5 (IC 22-4.1-2) to develop entrepreneurship education programs for  
 6 elementary and secondary education, higher education, and  
 7 individuals in the work force.  
 8 (5) Make recommendations to the governor and general assembly  
 9 concerning the educational needs of the state, including financial  
 10 needs.  
 11 (6) **For school years ending before July 1, 2016**, provide for  
 12 reviews to ensure the validity and reliability of the ISTEP  
 13 program **and, for school years beginning after June 30, 2016,**  
 14 **provide for reviews to ensure the validity and reliability of the**  
 15 **BEST program.**  
 16 SECTION 7. IC 20-19-2-14.5, AS AMENDED BY P.L.31-2014,  
 17 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 18 UPON PASSAGE]: Sec. 14.5. (a) As used in this section:  
 19 (1) "college and career readiness educational standards" means  
 20 ~~the~~ **Indiana** standards that a high school graduate must meet to  
 21 obtain the requisite knowledge and skill to transition without  
 22 remediation to postsecondary education or training, and  
 23 ultimately into a sustainable career; and  
 24 (2) "cut scores" means the scores that define a student's  
 25 performance on an assessment, including passing, failing, or  
 26 falling into a performance category.  
 27 (b) **The state board shall adopt college and career readiness**  
 28 **educational standards.** Before July 1, ~~2014~~, **2016**, the state board  
 29 shall adopt ~~the initial~~ **Indiana** college and career readiness educational  
 30 standards **that meet the requirement described in subdivision (7),**  
 31 voiding the previously adopted set of educational standards. The

 42 (5) Maintain Indiana sovereignty.



1 (6) Provide strict safeguards to protect the confidentiality of  
2 student data.

3 **(7) Align with the content of a nationally recognized and norm**  
4 **referenced assessment approved by the state board under**  
5 **IC 20-32-5.1. In setting standards, the state board may not**  
6 **adopt Common Core or delegate to any higher authority**  
7 **responsibility of selecting standards.**

8 (e) The department shall administer ISTEP assessments under  
9 IC 20-32-5 during the 2013-2015 biennium. During the 2015-2016  
10 school year, subject to subsection (e), the state board shall authorize the  
11 department to administer either the ISTEP assessment under  
12 IC 20-32-5 or a comparable assessment program that is aligned with  
13 the educational standards adopted by the state board under subsection  
14 (b).

15 (d) Before the state board may authorize an assessment program  
16 under subsection (e), the state board shall submit the proposed  
17 assessment program to the budget committee for review.

18 (e) This subsection does not apply to an agreement with the United  
19 States Department of Education concerning a waiver from federal  
20 requirements. After June 30, 2013, the state, or the state board on  
21 behalf of the state, may not enter into or renew an agreement with any  
22 organization, entity, group, or consortium that requires the state to cede  
23 any measure of autonomy or control of education standards and  
24 assessments, including cut scores.

25 (f) (c) The state board may adopt emergency rules in the manner  
26 provided in IC 4-22-2-37.1 to implement this section. As provided in  
27 IC 4-22-2-37.1 for an emergency rule adopted under this section to be  
28 effective after one (1) extension period, the rule must be adopted in  
29 conformity with the procedures under IC 4-22-2-24 through  
30 IC 4-22-2-36.

31 SECTION 8. IC 20-19-4-10, AS AMENDED BY P.L.286-2013,  
32 SECTION 15, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
33 UPON PASSAGE]: Sec. 10. The roundtable shall review and

12 (3) Additional information or explanation that the governing body  
13 wishes to include, including the following:

16 **program** that a school corporation, including a charter school,  
17 uses to determine if students are meeting or exceeding

21 than the ISTEP program **or the BEST program** that a school  
22 corporation uses to determine if students are meeting or  
23 exceeding academic standards in grades that are not tested  
24 under the ISTEP program **or the BEST program.**

25 (C) The number and types of staff professional development  
26 programs.

27 (D) The number and types of partnerships with the  
28 community, business, or postsecondary education.

29 (E) Levels of parental participation.

30 SECTION 10. IC 20-20-8-8, AS AMENDED BY P.L.246-2013,  
31 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
32 UPON PASSAGE]: Sec. 8. The report must include the following  
33 information:

34 (1) Student enrollment.

35 (2) Graduation rate (as defined in IC 20-26-13-6).

36 (3) Attendance rate.

37 (4) The following test scores, including the number and  
38 percentage of students meeting academic standards:

39 (A) **for school years ending before July 1, 2016**, ISTEP  
40 program test scores, **and for school years beginning after**  
41 **June 30, 2016, BEST program test scores.**

42 (B) Scores for assessments under IC 20-32-5-21 (**repealed**)

 11 IC 20-29-2-4).  
 12 (B) Teachers who teach the subject area for which the teacher  
 13 is certified and holds a license.  
 14 (C) Teachers with national board certification.  
 15 (16) The percentage of grade 3 students reading at grade 3 level.  
 16 (17) The number of students expelled, including the number  
 17 participating in other recognized education programs during their  
 18 expulsion.  
 19 (18) Chronic absenteeism, which includes the number of students  
 20 who have been absent from school for ten percent (10%) or more  
 21 of a school year for any reason.  
 22 (19) Habitual truancy, which includes the number of students who  
 23 have been absent ten (10) days or more from school within a  
 24 school year without being excused or without being absent under  
 25 a parental request that has been filed with the school.  
 26 (20) The number of students who have dropped out of school,  
 27 including the reasons for dropping out.  
 28 (21) The number of student work permits revoked.  
 29 (22) The number of student driver's licenses revoked.  
 30 (23) The number of students who have not advanced to grade 10  
 31 due to a lack of completed credits.  
 32 (24) The number of students suspended for any reason.  
 33 (25) The number of students receiving an international  
 34 baccalaureate diploma.  
 35 (26) Other indicators of performance as recommended by the  
 36 education roundtable under IC 20-19-4.  
 37 SECTION 11. IC 20-20-13-9, AS AMENDED BY P.L.133-2012,  
 38 SECTION 188, IS AMENDED TO READ AS FOLLOWS  
 39 [EFFECTIVE UPON PASSAGE]: Sec. 9. (a) This section applies to the  
 40 4R's technology program described in section 6(a)(1) of this chapter.  
 41 (b) In addition to any other funds available under this chapter, if  
 42 state funds are transferred under IC 20-32-5-19 (**repealed July 1,**



- 1       **2016)** to the 4R's technology program:
- 2           (1) those funds do not revert to the state general fund;
- 3           (2) those funds shall be made available to the 4R's technology

- 28               (E) That the school corporation, either through its own or the
- 29               school's initiative, is able to provide a part of the costs
- 30               attributable to purchasing the necessary technology equipment.
- 31          (3) The school corporation must include in the application the
- 32          sources of and the amount of money secured under subdivision
- 33          (2)(E).
- 34          (4) The school corporation or the school must:
- 35               (A) provide teacher training services; or
- 36               (B) use vendor provided teacher training services.
- 37          (5) The school corporation must give primary consideration to the
- 38          purchase of technology equipment that includes teacher training
- 39          services.
- 40          (6) The teachers who will be using the technology equipment
- 41          must support the initiative described in this chapter.
- 42       (d) Upon review of the applications by the department, the



1 satisfaction of the requirements set forth in subsection (c), and subject  
 2 to the availability of funds for this purpose, the department shall award  
 3 to each eligible school corporation a grant to purchase technology  
 4 equipment under section 6(a)(1) of this chapter.

5 (e) The department shall monitor the compliance by the school

7 SECTION 12. IC 20-24-4-1, AS AMENDED BY THE  
 8 TECHNICAL CORRECTIONS BILL OF THE 2015 GENERAL  
 9 ASSEMBLY, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 10 UPON PASSAGE]: Sec. 1. (a) A charter must meet the following  
 11 requirements:

- 12 (1) Be a written instrument.  
 13 (2) Be executed by an authorizer and an organizer.  
 14 (3) Confer certain rights, franchises, privileges, and obligations  
 15 on a charter school.  
 16 (4) Confirm the status of a charter school as a public school.  
 17 (5) Be granted for:  
 18 (A) not less than three (3) years *or more than seven (7) years*;  
 19 and  
 20 (B) a fixed number of years agreed to by the authorizer and the  
 21 organizer.  
 22 (6) Provide for the following:  
 23 (A) A review by the authorizer of the charter school's  
 24 performance, including the progress of the charter school in  
 25 achieving the academic goals set forth in the charter, at least  
 26 one (1) time in each five (5) year period while the charter is in  
 27 effect.  
 28 (B) Renewal, if the authorizer and the organizer agree to renew  
 29 the charter.  
 30 (C) The renewal application must include guidance from the  
 31 authorizer, and the guidance must include the performance  
 32 criteria that will guide the authorizer's renewal decisions.  
 33 (D) The renewal application process must, at a minimum,  
 34 provide an opportunity for the charter school to:  
 35 (i) present additional evidence, beyond the data contained in  
 36 the performance report, supporting its case for charter  
 37 renewal;  
 38 (ii) describe improvements undertaken or planned for the  
 39 charter school; and  
 40 (iii) detail the charter school's plans for the next charter  
 41 term.  
 42 (E) Not later than October 1 in the year in which the charter



- 1 school seeks renewal of a charter, the governing board of a  
 2 charter school seeking renewal shall submit a renewal  
 3 application to the charter authorizer under the renewal  
 4 application guidance issued by the authorizer. The authorizer  
 5 shall make a final ruling on the renewal application not later  
 6 than March 1 after the filing of the renewal application. The  
 7 March 1 deadline does not apply to any review or appeal of a  
 8 final ruling. After the final ruling is issued, the charter school  
 9 may obtain further review by the authorizer of the authorizer's  
 10 final ruling in accordance with the terms of the charter school's  
 11 charter and the protocols of the authorizer.
- 12 (7) Specify the grounds for the authorizer to:
- 13 (A) revoke the charter before the end of the term for which the  
 14 charter is granted; or
- 15 (B) not renew a charter.
- 16 (8) Set forth the methods by which the charter school will be held  
 17 accountable for achieving the educational mission and goals of  
 18 the charter school, including the following:
- 19 (A) Evidence of improvement in:
- 20 (i) assessment measures, including **for school years ending**  
 21 **before July 1, 2016**, the ISTEP, **for school years beginning**  
 22 **after June 30, 2016**, BEST, and **for school years ending**  
 23 **before July 1, 2015**, end of course assessments;
- 24 (ii) attendance rates;
- 25 (iii) graduation rates (if appropriate);
- 26 (iv) increased numbers of Core 40 diplomas and other  
 27 college and career ready indicators including advanced  
 28 placement participation and passage, dual credit  
 29 participation and passage, and International Baccalaureate  
 30 participation and passage (if appropriate);
- 31 (v) increased numbers of academic honors and technical
